Re: **Viguers Road and Main Road, Goulds, St. John's (Fourth Pond) - Installation of storm sewer pipeline,
construction of storm sewer drainage ditch and outfall**

The original Permit dated NOVEMBER 20, 2023 is amended as follows:

1. The permit is being amended to allow the installation of a closed conduit stormwater pipeline system instead of the previously proposed open ditch stormwater drainage system and to relocate the outfall location closer to the shoreline of Fourth Pond.
2. The new closed conduit stormwater pipeline will have a diameter of 450 mm, and the outfall will be placed at an elevation of 123.605 m.
- 3 All other terms and conditions of the permit will remain unchanged.

All other terms and conditions of the original Permit will apply and failure to comply with the terms and conditions of this amendment and the original Permit will render this Permit null and void, place the Permit Holder and their agent(s) in violation of the *Water Resources Act* and make the Permit Holder responsible for taking any remedial measures as may be prescribed by this Department.
