

Re: **4 Abigail Place, Conception Bay South (Monument Road River) - Culvert installation**

The original Permit dated APRIL 05, 2024 is amended as follows:

1. To permit cutting, grabbing, and land grading within 15 metres of a waterbody at 4 Abigail Place, Conception Bay South to facilitate the construction of a new house.
2. The culvert size and material are being changed to a 1400 mm diameter HDPE culvert instead of a 1500 mm CSP culvert.
3. All other terms and conditions of the permit will remain unchanged.

All other terms and conditions of the original Permit will apply and failure to comply with the terms and conditions of this amendment and the original Permit will render this Permit null and void, place the Permit Holder and their agent(s) in violation of the *Water Resources Act* and make the Permit Holder responsible for taking any remedial measures as may be prescribed by this Department.
