Description of Area:

Domestic areas 1 & 2 are located on Fogo Island.

Domestic areas 4, 5, 6, & 8 are located from Gander Bay to Ladle Cove.

Domestic areas 9, 10 and 11 are located from Deadman's Bay to Musgrave Harbour.

Domestic areas 12, 13, 14, 15, 16, 17, 18, 40 & 7 are located from Hare Bay to Lumsden.

Domestic areas 21, 26 & 35 are located via the Drover's Ridge Resource Road.

Domestic areas 19, 20 are located near Gambo.

Domestic Cutting area 23 located on the South side of the TCH between Gambo Pond and Gull Pond.

Domestic areas 22, 24 & 25 are located by Glovertown.

Domestic areas 27 & 28 are located on the Eastport Peninsula.

Domestic area 29 includes Cottle Island, Pitt Sound Island & Willis Island.

Domestic area 31 is located by Soulis (Benton) Pond and on the southeastern tip of Gander Lake beginning of Crown Ridge Resource Road.

Domestic area 32 is located on the west side Gander Bay road north of Gander.

Domestic area 33 is located on Gander Bay road at Weirs Pond road and Kinden's Ridge and to the west between the Gander River and the road.

Domestic area 37 is located on the east side of Terra Nova Lake and boarders TNNP.

Domestic area 39 is located north of Gander at Boot Pond Resource Road.

Domestic Cutting area 40 is located NW of the community of Indian Bay.

Harvesting Activities:

Timber in domestic cutting areas is for the most part not considered economically viable and is not considered for large scale commercial operations. District 5 does however have smaller scale commercial harvesting that occurs in domestic area 31 at 85m³/year.

Cutting Conditions Applied to Permits:

- . Crown domestic permits are issued for 23 m3/permit/year in FMD 5 with the exception of Fogo Island areas 1 and 2 which are issued for 18 m3/permit/year.
- . Crown domestic permits in District 5 are issued for the harvesting of mature timber comprised of softwood and hardwood with the exception of area 15 which is HARDWOODS ONLY.
- . Permittee not permitted to cut or damage immature timber.
- . Permittee not permitted to cut or damage silviculturally treated timber.
- . Permittee must comply with Forest Fire Regulations during the forest fire season.
- . No harvesting of white pine or red pine (dead or alive)
- . Cutting of deadwood and blowdown is permitted within 100 meters of the centre Line of any highway maintained by the Department of Works, Services and

Transportation, excluding private property and Municipal Land.

Non Timber Considerations and Mitigations:

A 30 meter buffer will be maintained on both sides of all rivers, brooks, ponds or other water bodies that are shown on 1:50,000 topographic maps.

On water bodies where an approved cabin development area exists a 105 meter buffer must be maintained along the shoreline.

Where an approved license to occupy for a cabin exists, a 20 meter buffer is to be maintained.

Each domestic cutting area has its own restricted areas where no harvesting can occur for a variety of reasons including but not limited to: silviculture exclusions, private ownership, municipal parks, RV parks, walking trails, snowmobile trails, ATV trails, Newfoundland T'Railway, viewscape buffers (not limited to Terra Nova River/Maccles Brook), and Protected Public Water Supply Areas. Refer to domestic cutting maps and their conditions for the specific considerations.

The following domestic cutting areas contain Protected Public Water Supply Areas (PPWSA) within their boundaries in which domestic cutting is permitted under specific environmental conditions within the associated protected watershed. The terms and conditions for harvesting are issued under a Permit for Development from the Water Resources Management Division. These conditions are issued with each domestic permit. Refer to domestic cutting map condition for the specific conditions.

- DCA 1
 - No cutting within PPWSA –
 - No cutting inside Island Harbour – Requested from the town of Island Harbour
 - No cutting within 100m of Roman Catholic cemetery
 - No Cutting in Silviculture area
- DCA2
 - No cutting within PPWSA.
- DCA4
 - No cutting within 100m of “The Line” road.
 - No cutting within silviculture areas.
- DCA5
 - 300m buffer on Barry's Brook, as well as First, Second and Third Pond. 50m buffer on all streams and tributaries flowing into Barrys Brook.
- DCA 6
 - No cutting in sensitive waterfowl area from April 1st to Nov 30th to allow for breeding, brood rearing and staging periods of waterfowl.

- No cutting within 50m of all waterbodies in the sensitive waterfowl area in Middle Arm
 - No cutting within Carmanville water supply
 - Area Southwest of Wetland Interpretation center and walking trails is no-cutting.
- DCA 7
 - 300m no-cutting buffer around First Pond (PPWSA source)
 - No cutting within 100m of walking trail in Black Brook Park as requested from Town of Centreville/Wareham/Trinity
- DCA 8
 - No special conditions
- DCA9
 - No special conditions
- DCA 10
 - 100m buffer along Anchor Brook (Eastern block boundary) (Scheduled salmon river)
- DCA 11
 - No cutting in Deadman's Bay Provincial Park
- DCA 12
 - No cutting within Windmill Bight Park
 - Winter harvest only (Nov15-April 15) to protect sensitive waterfowl
 - No cutting within New-Wes-Valley PPWSA.
 - No cutting within New-Wes-Valley's Town's area zoned "Open Space"
- DCA13
 - There is no cutting allowed in N WV PPWSA.
 - No cutting within New-Wes-Valley's Town's area zoned "Open Space"
- DCA 14
 - No cutting around Southwest Pond. This was requested by the RV park
- DCA 15
 - Hardwoods only
 - No cutting within 20m of NLSF trails as requested by NLSF
 - No cutting within Cabin Development area as requested from Crown Lands and cabin owners
- DCA 16
 - 100m no cutting along Northwest Brook (Scheduled salmon river)
 - No cutting within Indian Bay Town Limits (requested by Township)
- DCA 17
 - No cutting within PPWSA
- DCA 18
 - No cutting within 150m of the salt water in Town of Hare Bay Recreational Park
 - 500m no-cutting area between North shore of Hare Bay Pond to the cut line from Flammers Brook to Parkers Pond Brook
 - 150m Buffer around the entirety of Hare Bay Pond
- DCA 19
 - No cutting agriculture lease area.

- No cutting within 100m from Traverse Brook
 - No cutting in private property long Traverse Brook.
- DCA 20
 - A 50m buffer around the bog at the top of Gambo hill as well as the stream which flows into and out of this bog (no shown on Forest Inventory but does appear on NTS maps) This is to help prevent flooding downstream.
 - 150m Buffer around goose and dark cove ponds (PPWSA) requested by town
 - No cutting near Square Pond RV Park
 - No cutting around Black Duck Pond
 - 100m Buffer in Middle Brook, Butts Pond.
 - No cutting within 100m of T'railway or TCH
 - No Cutting Southeast of the Powerline near the Nordic Ski trails

 - No cutting in silviculture area
 - No cutting in agriculture area
 - No cutting of threatened Red Pine stands (Wild life division)
 - 100m Buffer along Northwest Brook (Salmon river)
