**Regulatory Advice from Government Screening Departments/Divisions**

**EA #: 2311 Dover Fibreglass Manufacturing Facility (the Project)**

**1 Pollution Prevention Division (PPD), ECC**

- 1.1 Proponent is advised to develop a contingency plan specific to the Project and to have spill response equipment readily available on-site to enable a quick and effective response to a spill event. Any spill or leak of gasoline or associated product is to be reported immediately to the Environmental Emergencies Telephone Line at 1-800-563-9089.
- 1.2 Registration is required for fuel storage tank systems other than those connected to a heating appliance of a capacity of 2,500 litres of less and may be required for devices or tanks used to separate and remove oily wastes from oil and water mixtures. For further information, please contact the PPD at (709) 729-5782.

**2 Water Resources Management Division (WRMD), ECC**

- 2.1 Proponent is advised that they must apply for and obtain a Water Use Licence for the use of water from any water source for any purpose, prior to the start of construction. This applies to all non-domestic uses with an existing, new or planned water use from any water source.
- 2.2 If a well is required, the Proponent must apply for and obtain a Permit for Constructing a Non-Domestic Well for drilled well(s) along with following necessary groundwater monitoring requirements prior to the start of construction. For further information, contact Groundwater Section at (709) 729-2539.
- 2.3 Any effluent or runoff leaving the site is required to conform to the requirements of the Environmental Control Water and Sewage Regulations. For further information, please contact the WRMD at (709) 729-2563.

**3 Government Service Centre (GSC), Dept. of Digital Government and Service NL (DGSNL)**

- 3.1 A Development Permit is required under the Protected Road Zoning Regulations prior to any construction/development, as this proposal is located within the building control lines of Route 320.
- 3.2 All propane system installations exceeding 211,000 kilojoules (200,000 BTU) are subject to the Boiler, Pressure Vessel and Compressed Gas Regulations under the **Public Safety Act** and will require approval prior to installation. For further information contact the GSC at (709) 729-2008.
- 3.3 Any spill or leak of gasoline or associated product is to be reported immediately to DGSNL by calling the Environmental Emergencies Telephone Line at 772-2083 or 1-800-563-9089.

#### 4 Crown Land Application #63936

4.1 The Department of Fisheries, Forestry and Agriculture (FFA), Land Management Division advises that this undertaking is currently under Crown land application and Crown title must be issued prior to any Project development. For more information, contact FFA at (709) 637-2950.

#### 5 Occupational Health and Safety (OHS), DGSNL

5.1 Proponent is advised to ensure that activities are conducted in compliance with the **Occupational Health and Safety Act** and its Regulations. This includes the responsibility for ensuring that contractors hired to perform work also comply with this legislation, as per **OHS Act**.

#### 6 Dept. of Fisheries, Forestry and Agriculture (FFA)

6.1 Proponent is advised to operate under established legislation and regulations, such as the **Wild Life Act** and Wild Life Regulations, to avoid or minimize adverse impacts. For further information, please contact FFA at 709-637-2950.

#### 7 Environment and Climate Change Canada (ECCC)

7.1 An oil spill prevention and response plan is recommended.

7.2 A contingency plan that considers potential accidents and malfunctions that take into account site-specific conditions and sensitivities is recommended.

7.3 All spills or leaks, such as those from machinery or storage tanks, should be promptly contained and cleaned up (sorbents and booms should be available for quick containment and recovery), and reported to the 24-hour environmental emergencies reporting system (1-800-563-9089).

#### 8 Fisheries and Oceans Canada (DFO)

8.1 Proponent is advised that the modernized **Fisheries Act** includes fish and fish habitat protection provisions which came into effect on August 28, 2019. Proponent should refer to the Projects Near Water website to get information about how to comply with the **Fisheries Act** and information on the project review process when conducting work in or near water. 8.2 Advised that the Proponent is responsible for:

- Understanding the impacts the Project will likely have on fish and fish habitat;
- Taking measures to avoid and mitigate impacts to fish and fish habitat; and

- Requesting an authorization from the Minister and abiding by the conditions of the authorization when it is not possible to avoid and mitigate project impacts on fish and fish habitat.

8.3 Advised that Project falls within a waterbody where a Fish and Fish Habitat Protection Program (FFHPP) review is required or the scope of the Project is not covered under the Ministry's standards and codes of practice, and the Proponent must submit a request for review to the NL Region FFHPP.
