The Honourable Lisa Dempster, Minister of Environment and Climate Change, has announced the following relative to Environmental Assessment - Part 10 - of the **Environmental Protection Act**.

UNDERTAKING REGISTERED:

Gander Area Queensway North Mineral Exploration (Reg. 2343)
Proponent: New Found Gold Corp.

The proponent is proposing to continue advanced mineral exploration activities including core drilling on the Queensway North property located northeast of the communities of Appleton and Glenwood.
