The Honourable Chris Tibbs, Minister of Environment, Conservation and Climate Change, has announced the following relative to Environmental Assessment - Part 10 - of the **Environmental Protection Act**.

Undertakings Registered:

Humber Valley Residential Development (Reg. 2386)
Proponent: Jane Chaulk

The proponent is proposing to construct a one and a half-story dwelling on a residential lot located at 305 Marble Drive in Steady Brook, with the property bounded to the north by the Humber River. The land is currently developed with a mobile home, an existing driveway, and landscaping. Construction would include installation of a sewer system and the excavation of the dwelling's footprint.
