
Re: **Gander WSMC and Gambo - Gander Lake and Dark Cove Pond PPWSAs - Transmission Line Rebuild -

The original Permit dated JULY 09, 2024 is amended as follows:

This Permit is amended to permit the following:

1. The use of heavy equipment for vegetation cutting to within 150 meters of Gander Lake, 100 meters of Soulis Brook and 50 meters of all other water bodies inside the Gander Lake Protected Public Water Supply Area.
2. The use of CCA treated poles with pole wraps between 300 meters and 150 meters of Gander Lake. All wood used for rock cribbing within the buffer zones outlined in Condition 5 must be untreated.

All other terms and conditions of the original Permit will apply and failure to comply with the terms and conditions of this amendment and the original Permit will render this Permit null and void, place the Permit Holder and their agent (s) in violation of the *Water Resources Act* and make the Permit Holder responsible for taking any remedial measures as may be prescribed by this Department.
