## Overview

---

The Wilderness and Ecological Reserves Advisory Council (WERAC) advises Government through the Minister of Environment and Climate Change on wilderness and ecological reserves in the province. The **Wilderness and Ecological Reserves Act**, 1980, under Section 7, establishes and mandates an Advisory Council (WERAC), to advise the Lieutenant-Governor in Council (through the responsible Minister) on the establishment, management and termination of wilderness and ecological reserves.

WERAC, with support from the Department of Environment and Climate Change's (ECC) Natural Areas Program staff, works to ensure that all public and private interests are considered when reserves are being planned and established. Local public consultations are required as part of the establishment process, as outlined in section 16 of the **Act**. WERAC then presents its recommendation to Government with the Lieutenant-Governor in Council making the final decision on establishment. Conducting public consultations regarding the establishment of wilderness and ecological reserves, and advising government on the development and management of a system of properly designed and legally designated protected areas are two of the key ways WERAC works to ensure the preservation of Newfoundland and Labrador's natural heritage. Appendix A includes further detail on the legislated mandate of WERAC. Additional information on WERAC's vision and lines of business are included in Appendix B.

WERAC consists of up to 11 members appointed by the Lieutenant-Governor in Council for a three-year term. A list of WERAC membership for 2023-24 is included in Appendix C. Two new members were appointed to WERAC in February 2024.

WERAC members serve as volunteers. However, travel for WERAC business, including accommodations and related costs, is covered and reported through the budget of the Policy, Planning and Natural Areas Division of ECC. Please refer to the section on WERAC financial information for an explanation of expenditures during the reporting period.

WERAC met four times during the 2023-24 reporting period, in St. John's, Corner Brook, and virtually.

## **Highlights and Partnerships**

---

WERAC's continued focus through this fiscal year was advancement of recommendations related to the provincial government's proposed Protected Areas Plan for the Island portion of the Province. In May 2023, Government of Newfoundland and Labrador directed WERAC to begin consultations on ten new proposed protected areas, nine of which are included in the proposed Protected Areas Plan for the Island.

A Home For Nature: Protected Areas Plan for the Island of Newfoundland and Labrador was released by Government and presented to the public by the Wilderness and Ecological Reserves Advisory Council in 2020. The Plan represents a big step towards completion of a comprehensive system of protected areas that protects the Province's biodiversity and natural heritage, supports a vibrant culture and sustainable economy, and enhances public understanding and enjoyment of the natural environment. Phase one public consultations were launched on the Plan in May 2020.

Public consultations were held for the Indian Arm Brook Proposed Protected Area in 2023-24. In addition to direct and online engagement, two in-person meetings were held: one in Lewisporte and one in Norris Arm. WERAC's efforts this fiscal have focused on community engagement, seeking opportunities to work with like-minded organizations, and developing relationships with Indigenous groups. The Council, through the Labrador subcommittee, has also begun discussions about strategies for moving forward with protected areas planning for Labrador.

## **Report on Performance**

---

### **Objective Indicators for the 2023-24 Year**

Objectives and indicators outline accomplishments achieved for the 2023-24 fiscal year. The two following objectives reflect WERAC's vision. They are based on the advancement of proposed protected areas and increased public awareness and participation in the establishment and management of protected areas in Newfoundland and Labrador. These activities help government achieve its objective of enhanced management of our Province's natural environment and support efforts to reach Canada's protected area targets.

## 1. Establishment and Management

WERAC advises government on the establishment, management, and termination of the province's wilderness and ecological reserves. WERAC succeeded in meeting this objective over the 2023-24 reporting period.

**Objective 1:** By March 31, 2024, WERAC will have advised government on the establishment and management of wilderness and ecological reserves in Newfoundland and Labrador.

## 2. Education and Awareness of Protected Areas

During the 2023-24 reporting period, WERAC increased public awareness and participation in activities associated with the establishment and management of protected areas in Newfoundland and Labrador, specifically about the value of protected areas, the Protected Areas Plan for the Island of Newfoundland, and reserve management.

**Objective 2:** By March 31, 2024, WERAC will have promoted an awareness and understanding of protected areas around the province and the role of the Council.

## Opportunities and Challenges

WERAC is pleased that, two new members were appointed during the planning period resulting in a full 11-member council. These appointments represent new voices and perspectives on the Council. They will be of great assistance as the Council listens to the public about the establishments of new protected areas across the province.

WERAC continues to recognize that there is an opportunity, and need, with additional public engagement to increase the level of public education about protected areas, improve transparency, and increase the level of engagement for protected areas establishment and management. WERAC looks forward to continuing to share information with the public about our province's natural spaces.

WERAC views local public engagement processes as opportunities to build connections and work together to establish protected areas in the province that benefit both nature and people. WERAC looks forward to engaging residents of the province in 2024-25 and continuing discussions about protecting our provinces ecosystems, mitigating the effects of climate change, and addressing biodiversity loss.

### **Financial Information**

---

WERAC does not have a stand-alone budget and as a result, audited financial statements are not required. Expenses associated with WERAC activities are funded through ECC. WERAC spent a total of \$39,447 in the 2023-24 reporting period. WERAC spent \$16,338 in 2023-24 for travel (including staff support), and approximately \$187 for conference calling, as well as an estimated \$600 for a mobile phone for the WERAC Secretariat. The following amounts were also spent on WERAC meetings and public engagements, through the expenses funded by ECC:

- Meeting room rental: \$375;
- Meeting supplies: office supplies and food/coffee: \$1,410;
- Public engagement costs (room rental, event tickets, software (scheduling and data analysis)): \$5,110; and,
- AV equipment and plotter: \$15,427.



## **Appendix A**

### **Legislated Mandate**

(Source: **Wilderness and Ecological Reserves Act**)

#### **Advisory Council**

6. The Wilderness and Ecological Reserves Advisory Council is continued for the purpose of advising the Lieutenant-Governor in Council through the minister on matters in relation to the establishment, management and termination of reserves and for the better administration of this Act.

#### **Powers of council**

11. (1) The advisory council may examine an area of the province in order to determine which areas are suitable for the establishment of a reserve.

(2) The advisory council may accept recommendations from the public in relation to the establishment of or a change in a reserve.

#### **Duties of council**

12. (1) The advisory council shall give information on the areas determined as suitable for the establishment of a reserve under section 11 to interested departments of the governments of the province and Canada and to interested Councils, commissions or other bodies, whether incorporated or unincorporated, members of which or the members of the Council of management or Council of directors of which, are appointed by an Act or by the Lieutenant-Governor in Council.

(2) Where, in the opinion of the advisory council, the comments received under subsection (1) from the interested departments and bodies do not change the opinion as to the suitability of the area for the establishment of a provisional reserve, the advisory council shall give a report to the Lieutenant-Governor in Council.

#### **Information on reserves**

15. Within one year from the date of the establishment of a provisional reserve, the minister shall prepare and publish, in a newspaper in circulation in the area of the provisional reserve, a notice that contains

(a) a boundary description of the area of the proposed reserve;

(b) an outline of the management plan of the proposed reserve; and

(c) a statement indicating that the minister requires written notice within the next 30 days where a member of the public intends to participate in a public hearing on the establishment of the reserve.

## **Public hearing**

16. (1) The minister shall set a time and place for the holding of a public hearing by the advisory council to consider submissions, representations and objections respecting the establishment of a reserve including the boundary description and management plan of the proposed area.

(2) The time of the holding of a public hearing shall be within 90 days of the date of publication of the notice referred to in Section 15 but after 30 days notice has been given to the public of the time and place of the hearing.

## **Report to Lieutenant-Governor in Council**

17. (1) The advisory council shall report in writing to the Lieutenant-Governor in Council, through the minister, on the advisability of the establishment of a reserve including a review of the benefits and disadvantages of the establishment, and with a review on public hearing proceedings held under section 16, including its assessment of objections or reservations raised at the hearing.

(2) A report under subsection (1) shall be made within 120 days of the public hearing.

(3) Where the advisory council in its report made under subsection (1) recommends the establishment of a reserve, it shall include in that report

- (a) the boundary description, management plan and proposed regulations in relation to that proposed reserve as revised in consideration of the public hearing; and
- (b) comments on the rights and interests affected by the establishment of a reserve and an estimate of the compensation for those rights and interests.

## **Appendix B**

### **Vision and Lines of Business**

WERAC's vision is the conservation and preservation of natural landscapes and seascapes in Newfoundland and Labrador for current and future generations through the timely establishment of a functioning network of protected areas throughout the province of Newfoundland and Labrador.

The Council's lines of business include:

- Examining areas of the province in order to determine which areas are suitable for the establishment of a reserve (i.e., three criteria guide reserve creation, large wilderness areas, ecosystem representation and rare natural phenomena);
- Accepting recommendations from the public in relation to the establishment of, change to, or termination of a reserve (i.e., through presentations, letters of nomination, etc.);
- Consulting stakeholders and conducting public hearings to consider submissions, representations and objections respecting the establishment, change to, or termination of a reserve;
- Reporting to the Lieutenant-Governor in Council, through the Minister, on the advisability of reserve establishment. This includes a review of the benefits and disadvantages of the establishment, and with a review of the public hearing proceedings; and
- Making recommendations to the Minister on the management of existing reserves.
