The Minister has advised the proponent that an Environmental Preview Report (EPR) is required for this project. The EPR is necessary to address deficiencies in the registration document in an effort to determine the significance of any environmental effects. An Environmental Assessment Committee will be appointed to provide advice to the Minister on Guidelines for the proponent on the preparation of the EPR and the adequacy of the EPR when it is received from the proponent. The public will be invited to provide comments on the EPR upon its submission. The proposal is for a 19-lot chalet development adjacent to The Wilds Golf Course bordering the Salmonier River. The course is located on Salmonier Line (Route 90), approximately 16 kilometres south of the Trans Canada Highway. The 19 lots will range from 0.2161 hectares to 0.577 hectares and the project will include a total of 580 metres of roadway.

The undertaking was registered on September 28, 2007; the deadline for public comments is November 5, 2007; and the Minister's decision is due by November 12, 2007.

Comments on submitted documents are invited from the public, addressed in writing to the Minister, prior to the deadline date shown.
