#### THE UNDERTAKING:

- (i) Nature of the Undertaking: Construction of All Terrain Vehicle (ATV) Trail
- (ii) Purpose/Rationale/Need for the Undertaking:  
Construction of approximately 7km. ATV trail for access to 6 cabins at Tug Pond and Frost Pond, when cannot be accessed by snowmobile.

#### DESCRIPTION OF THE UNDERTAKING:

- (i) Geographical Location:  
See attached map, #2D1 with scale 1:50,000. Access to cabins obtained from existing registered trail that ends at the beginning of Tug Pond. The proposed trail starts at the beginning of Tug Pond and continues to Robert Avery's cabin at Frost Pond.
- (ii) Physical Features:  
The proposed trail as indicated on the map provided, will be 2m wide the full length of the trail, which is approximately 7km.

(iii) Construction:

There is approximately 50'-75' of open country that will be corduroyed. This trail travels mostly through barrens (75%) and woods (25%). Construction is planned for the Winter / Spring of 2004 and will take 4 –5 days to complete using ATV, chainsaws and hand tools. This trail will be built by cabin owners on Tug Pond and Frost Pond and will not involve any heavy equipment. Also, no pesticides or herbicides will be used to maintain or construct this trail.

(iv) Operation:

This ATV trail will provide all year round access to 6 remote cabins.

(v) Occupations:

The said trail will be used by all cabin owners who are near Tug Pond and Frost Pond.

(vi) Project-Related Documents:

The Proponent will require a Crown Land Permit (File Reference No. 1030223, Application No. 124774 – Permission to Occupy ATV Trail)

**APPROVAL OF THE UNDERTAKING:**

The Lands Officer of the Department of Government Services & Lands – Eastern Region, the Department of Forest Resources & Agrifoods, The federal Department of Fisheries, the Department of Environment, Water Resources Division, and Historic Resources Division, have been notified, and have already approved this project.

**SCHEDULE:**

Once approval is received for the ATV trail, the Proponent plans to commence construction of the trail in March 2004, providing there is no snow in the country. It is desired by the Proponent to have access to their cabins by mid summer.

**FUNDING:**

The total cost of constructing this ATV trail will be paid by the proponent.
