THE UNDERTAKING:

Nature of Undertaking: To make necessary improvements to already existing trail. The existing trail is not maintained and is scarcely visible except from Route 210 to the transmission line (refer to attached maps). The approximate width of trail is 2-3 metres. Approximate length of trail is 10kms.

Purpose/Rationale/Need for Undertaking: To access remote camp registered in my name by use of ATV mainly during the fall of the year. Remote camp has the Crown Lands No. CL117451.

DESCRIPTION OF UNDERTAKING:

- (i) Geographical Location: Refer to attached maps. The commencement of the proposed ATV trail is located approximately 8kms to the southwest of Piper's Hole Provincial Park and 10kms to the southwest of the town of Swift Current following Route 210 (Burin Peninsula highway).
- (ii) Physical Features: A metal-structure transmission line follows along Route 210 approximately ½ of a kilometre from commencement of trail running nearly parallel to Route 210. The already existing trail is approximately 2-3 meters wide and approximately 12 km in length. There are bogs, grasslands, low brush and hard ground along the proposed route. There are also a couple of small streams which have to be crossed to follow trail. Known wildlife in the area are moose, bear, caribou, rabbits, ptarmigan, grouse, foxes, coyotes and various bird species. There are also some ponds in the area.
- (iii) Construction: Very minimal. I intend to build small wooden bridges for stream crossings and use sections of guardrail and/or wooden pallets on wet areas and holes. Chainsaw and ATV (and trailer) will be used for construction activities. Airborne emissions would be smoke as well as gas and oil (emissions from chainsaw and ATV).

(iv) Operation: Construction activities will be done from August to December and possibly during the winter if the weather allows it. This trail will be used primarily during the fall of the year when the ground is not frozen or snow covered. All materials will be utilized properly and all waste will be packaged and disposed of properly.

(v) Occupations: There will be no employment. A friend and I will make the necessary improvements when time permits us to do so.

(iv) Project-Related Documents: Map from Crown Lands showing location of trail and remote cabin.

APPROVAL OF THE UNDERTAKING:

I am not sure which permits are required however I have a document that describes what is needed for a development permit and have attached it for your review. If there are any problems please contact me.

SCHEDULE:

Work will begin this coming August or fall of 2012 depending on approval to begin trail.

FUNDING:

No funding has been applied for as this is a personal undertaking.

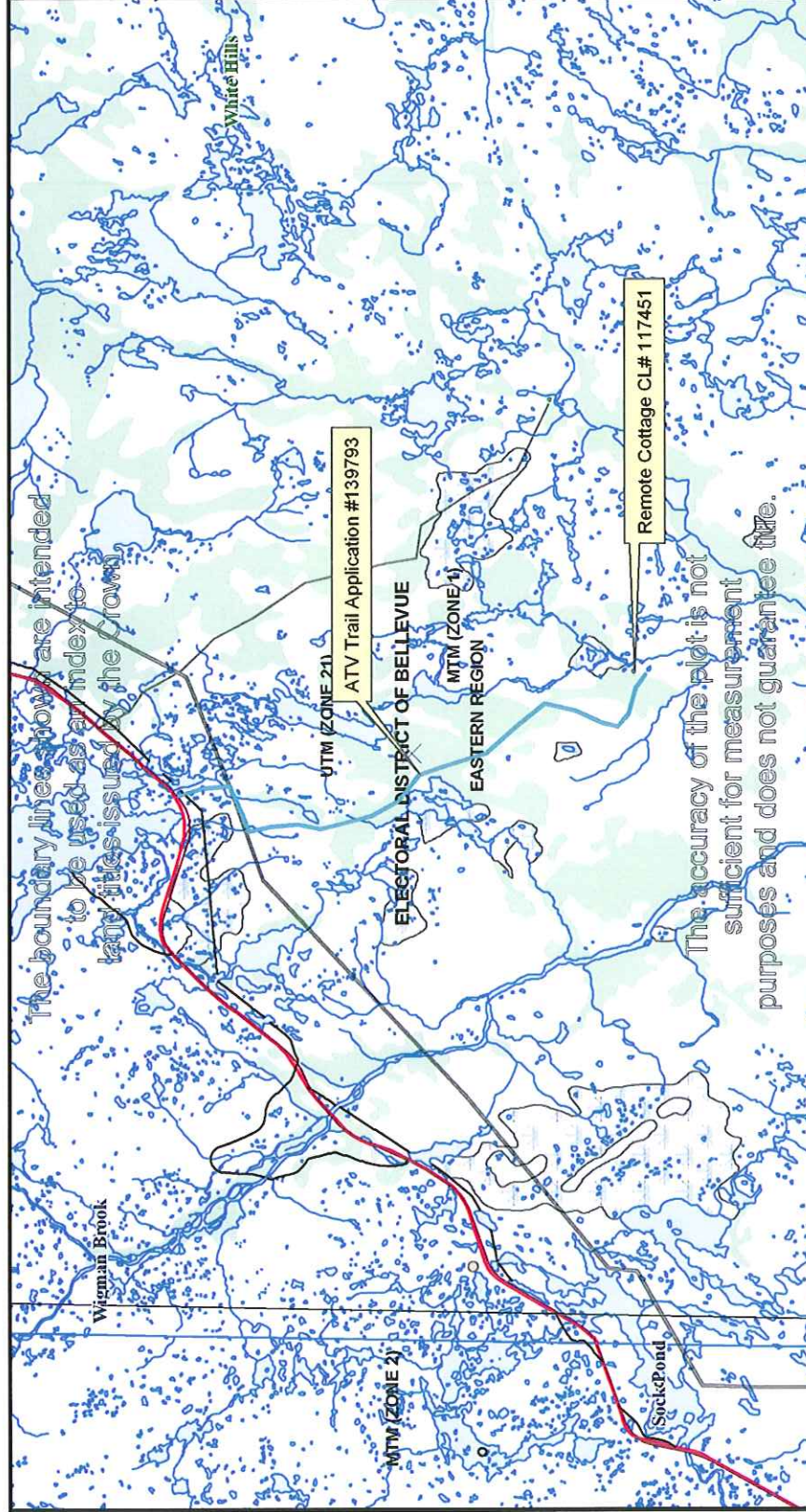
