i: **Nature of the undertaking:** Aggregate Quarry (Sand & Gravel)

ii: **Purpose of the undertaking:** To supply sand & gravel to surrounding cabin owners.

**4. Description of the Undertaking:**

i: **Location:** Purposed pit is of TCH in Gambo-Butt's Pond in same area to a pit  
Already in use by Wareham H & sons Ltd .

ii: **Pit Access:** The access to this pit would be of TCH and then of cabin access  
Road.

iii: **Coordinates:** located on attached Government Map.

iv: **Attached Map:**

v: **Physical Features:** The purposed quarry is bare field with very little vegetation. There are no buildings to be erected and there is already access to the site with No upgrades needed.

vi: **Construction:**

- i: Road access to the quarry location does not require any upgrades
- ii: Grubbing of overburden.
- iii: Pit development and sediment control

vii: **Clearing:** A grubbing material will be stock piled and used for reclamation.

5. **Operations:**

- ...Removal of screened gravel and pit run through excavation, screening will be done on site, and delivered to local cabin owners.
- ...Equipment in use will be front end loader and dump truck.(One operator).
- ...Period of operation is from April to November.
- ...The grounds will be maintained according to environmental health and safety standards. A spill recovery kit will remain on site at all times.
- ...No drilling or blasting will take place.

6. **Termination of Operation/Reclamation:**

- i: Life expectancy of the pit is 50 + years
- ii: Pit will be sloped and overburden will be replaced every fall to reclaim what is Disturbed up to pit face.
- iii: At the end of the pit life the entire mined area will be seeded to reproduce its Natural landscape.
