

ADVENTURE SUMMER PROGRAM (LEVEL 1/GRADE 10)

Description of the Program

Level 1 (Grade 10) students can apply for a bursary to attend a 4-week summer program in French in Quebec. The Level 1 program is open to all Grade 10 students regardless of their level of French (beginner to advanced). Bursaries are paid directly to the institution and cover the cost of tuition, room and board, instructional materials and all compulsory activities.

Eligibility Criteria

To be eligible, a candidate must:

- be a full-time Level I student during the school year;
- be a Canadian citizen or have been lawfully admitted to Canada for permanent residence in accordance with the provisions of the Immigration Act;
- and permanently live in Newfoundland and Labrador.

Required Documents

Scanned copies of **one** of the following must accompany all applications:

- Proof of Canadian citizenship;
- Proof of being lawfully admitted to Canada for permanent residence in accordance with the provisions of the Immigration Act; or
- A Canadian birth certificate.

NOTES:

- Submit application with appropriate supporting documents.
- Do not submit unrequired documents.

Application Process

The Adventure program will be relying on **Google Form** to collect applications from students and their parents/guardians.

The student and their parent/guardian should complete the required sections, upload the required documents, and submit the form. After submitting the application, a confirmation message will appear on the screen acknowledging receipt.

NOTES:

- It is the responsibility of the applicant to ensure that the application and required documents are submitted by the deadline.
- Application status will be communicated by email shortly after the deadline.
- Late applications will be rank-ordered based on the date and time received. Applications received after the deadline will only be considered after on-time applicants have been awarded a bursary.

Registration Fee

If selected, the student will be required to pay a registration fee of **\$125**. This fee will be refunded upon successful completion of the program. However, **if the student does not complete the program, the fee will not be refunded.**

Recommendation Process

Requests for recommendations from schools and from teachers will be handled separately from the application process. After registration closes, Programs and Services Division will send separate recommendation requests to the student's school, namely principal or assistant principal, and the student's teacher.

Information about Successful, Unsuccessful, and Cancelled Applications

- The selection process is completed via random selection.
- Successful applicants will be assigned a bursary at Collège Saint-Charles-Garnier. **Please wait to get confirmation from the institution before making airline reservations.**
- Unsuccessful applicants will be queued in a wait list. Any cancelled bursaries will be offered to wait-listed applicants by random selection.
- Candidates who wish to decline their bursary **must notify** adventure@gov.nl.ca **immediately.**

Additional Information

- The program is four weeks in duration.
- Bursaries will be paid directly to the institution.
- Bursaries will cover the cost of tuition, room and board, instructional materials, and all compulsory activities.
- Recipients will be responsible for their own transportation costs and pocket money, as well as the cost of the (refundable) registration fee. See above for more information on the Registration Fee.
- Recipients will live in student residences on campus; 1 or 2 students per room.
- The Programs and Services Division will contact the institution on behalf of the successful candidates. The institution will then forward further information, including required online registration, to recipients.
- No allowance is made for late arrivals or early departures except in emergency circumstances.
