### 1) Administration

- The teleconference meeting convened at approximately 0900 PT; 1000 MT; 1100 CT; 1200 ET and 1330 NT.
- A round of introductions was conducted.

## **2) Possible Amalgamation of CFVRF into the Energy Resources Committee.**

- Unfortunately Jim was unavailable to give specific details.
- James will be presenting at the Energy Resources Committee in Montreal on May 2, 2010. He will give an overview of what the CFVRF is and what it's mandate is.
- Todd Paget will be joining James in Montreal.
- James will give the CFVRF feedback from the ERC meeting in Montreal and specifically try to find out how exactly the team would fit into the ERC.
- General concern among the team – Is it a good fit?
- CFVRF is still not sure how ERC fits within CAMPUT
- ERC has a broad agenda – Would it dilute our purpose as a team?
- Amalgamation would bring information sharing of flaring and venting to a smaller part of the whole.
- Possible solution – Smaller working group, i.e the CFVRF feeds into the larger ERC?

## **3) Update from Environment Canada regarding the Federal Regulatory Framework for Air Emissions. (Lynne)**

- Unclear what the Americans are going to do.
- Still not sure what the framework for offsets and credits looks like.
- Not 100% clear whether to go to cap and trade.
- U.S. looking at regulating facilities emitting 25 kilotonnes CO<sub>2</sub>e or more.
- U.S. is confident that technologies are available to accurately measure CO<sub>2</sub>e.
- U.S. looking at facilities as a basin approach, rather than individual wells or facilities.
- USEPA is not sure what is going to happen. Cap and trade system seems to be in flux.
- IPCC (Intergovernmental Panel on Climate Change) has adopted 25 as the multiplier for calculating CO<sub>2</sub>e.
- Just not a lot of clarity right now.
- Oilsands amount to 5% of national inventory of CO<sub>2</sub>e emissions. Conventional Oil and gas account for approximately 8%.

## **4) Update from the World Bank – GGFR partnership.**

- James gave a quick update from the GGFR workshop in Mexico. Mexico has a new Hydrocarbon regulator and is wanting to learn from Canadian experiences.
- Jim attended the GGFR Steering Committee meeting in Paris in March.
- CIDA has approved participation in the GGFR for its 3<sup>rd</sup> term.
