## 2) Previous Action items:

- Jim, Kevin and Paul have been working on the harmonization of flare and vent definitions. Meetings will be scheduled soon to discuss the idea with CAPP and SEPAC.
- The Canadian Country Implementation Plan for the GGFR needs to be updated. It currently has 2007 numbers in it. James will be asking member jurisdictions soon for the respective flare and vent numbers for 2010. – Update: James will be asking for 2011 numbers later this year to update the plan.

## 3) New items.

- Fannie – Venting information – Bliers extended for 3 months
- Looking into Directive 060 being implemented federally.
- Randy – Zak Semaine – Alberta's representative on Bliers
- Venting aligned with Directive 060.
- Jim S. – Looking at VOC's not including methane.

- May have a tour of the Manitoba Geological Society 3D Theatre of Geological Formations.
- Request from Mike Layer to have Roger Fernandez from the USEPA come and talk to us about the USEPA's 'Subpart W' legislation.
- Team agreed to invite Roger.

- Environment Canada has a contribution agreement with Dr. Matt Johnson.
  - \$100,000. Intent of measuring soot and black carbon.
  - Related to PTAC.
- Dr. Matt Johnson (Carleton University) is doing further research with the University of Alberta on what else could be entering a flare stream.
- Suggestion made to invite Matt to our June meeting.
