## 2) Next face to face meeting

- The team was in agreement that the next face to face meeting should take place in Edmonton/Devon, Alberta on Thursday June 12<sup>th</sup> and Friday June 13, 2014.
- It was mentioned to the team that these dates coincide with the Global Petroleum Show being held in Calgary on June 10-12.

- The theme of the meeting will be flaring and venting during unconventional operations.
- Suggested agenda items are:
  - o Discuss interests/viewpoints/experiences of the different jurisdictions on unconventional resource development.
    - Hydraulic Fracturing
  - o Fugitive emissions – how different jurisdictions handle them.
  - o Roger Fernandez from the US EPA discussion on regulatory development in the US and US Subpart W.
  - o Emissions from flaring and venting from hydraulic fracturing operations – dealing with stakeholders and balancing the misinformation.
  - o Request from CNSOPB for a discussion regarding sour gas operations.
    - 10-15 minute presentation.
    - Concerns of sour gas operations and acid gas injection in the Deep Panuke project.
  - o Electrical generation from waste gas.
    - Manitoba has a 200 kW project.
    - Appetite for a discussion around other electrical generation projects in other jurisdictions.
  - o Presentation on collecting and trucking compressed natural gas from well sites where conservation by pipeline is not available.

- Suggestion that Dave Picard from Clearstone Engineering present on the micro condensation unit used in Mexico to knockout liquids in the flare stream.

#### **4) Updates from the member jurisdictions**

##### **- Alberta Energy Regulator**

- Big reorganization since June 2013. The AER is a brand new organization, not a rebranding of the old ERCB.
- The flaring and venting team was disbanded – reporting to different groups. (We still work with each other just not in a single team).
- Still a lot of unknowns about strategic direction, etc.

##### **- BC Oil and Gas Commission**

- LNG projects are consuming a lot of time.
- There are a lot of proposals for LNG projects – not sure how many will see fruition.
- Significant increase in solution gas flaring.

##### **- Saskatchewan**

- Implemented a levy to industry on April 1, 2014.
  - Used to be fees based on license applications, etc.
- Looking at the proliferation of single well batteries in SE Sk.
- Looking at increasing setbacks
- Looking at improving notifications
- CAPP is recommending the adoption of AER Directive 056 for licensing applications.
- Told by the Minister to put together and implement administrative penalties for non-compliances.
- Sk. S10 – Flaring regulations – challenges for gas conservation due to lack of conservation infrastructure.

##### **- Manitoba**

- January 1<sup>st</sup>, 2014 – Companies now required to submit more battery information.
- A new royalty structure has been implemented in Manitoba.
- A solution gas initiative has been implemented where royalties are not charged on conserved solution gas.
- Petroleum Branch is struggling with staffing challenges due to budgetary constraints.

##### **- Northwest Territories**

- Pursuing the promotion of best practices for flaring and venting.
- Interested in learning more about flow testing requirements.

- **National Energy Board**
  - April 1<sup>st</sup>, 2014 – Devolution of some regulatory powers to the GNWT.
  - Still regulate offshore.
  - CAGOA is changing
    - More transparency
    - Monetary penalties
    - Fracfocus uploads for GNWT.
    - Imperial Oil has applied for an exploratory well in the Beaufort Sea.
- **CNSOPB**
  - 2 TCF produced to date.
  - 18 wells – some are cycling
  - EnCana Deep Panuke – producing 300 MMCF/day
    - Deep Panuke has an acid gas disposal well.
    - 13 year lifespan.
  - Shell and BP have acquired licenses for offshore NS.
- **CNLOPB**
  - Flaring volumes are the same as last year.
    - More upsets as infrastructure gets older.
    - Flaring 2-4% of total gas production.
  - Two new platforms being constructed.
    - In operation in 2017.
  - StatOil made a major discovery.
  - Significant discovery of gas and the operator is looking at LNG to Europe.
  - St. John's is booming.
  - 30% growth over the next year.
- **Environment Canada**
  - AQMS –Some announcements are forthcoming.
  - VOC's work – potential requirements for GHG's.
- **CanmetENERGY/NRCan**
  - Representing Canada in the Climate and Clean Air Coalition (CCAC) under the UN Environmental Program.
    - Looking at Black carbon/Methane and HFC's
    - Canada is one of 6 founding members.
    - US is very engaged in CCAC
