Departmental Overview

Organizational Structure

Located within the Office of the Executive Council, the Intergovernmental Affairs Secretariat (the Secretariat) is the Government of Newfoundland and Labrador's lead entity for coordinating the Province's intergovernmental and trade priorities.

The Secretariat's three divisions work to frame policy advice on economic, social, and trade priorities ensuring our province's unique needs and circumstances are at the forefront of intergovernmental dialogue and negotiations. Through the delivery of numerous diplomatic visits and international missions, the Secretariat also works to promote Newfoundland and Labrador's interests on the international stage.

- The Economic Policy Division provides intergovernmental policy advice related to measures that promote sustainable economic growth, including in the areas of natural resource management, the environment, fiscal and economic policy, industrial and technology development, infrastructure and other matters of constitutional interest. The division also supports provincial participation in First Ministers' Meetings (FMM), the Council of Atlantic Premiers (CAP), the Atlantic Growth Strategy (AGS), and the Conference of New England Governors and Eastern Canadian Premiers (NEG-ECP).
- The Social Policy Division provides intergovernmental policy advice related to measures that improve the well-being of individuals, families and communities, including in the areas of health, housing, education, immigration, population growth, skills and labour, reconciliation and inclusion, tourism, justice and public safety, and women and gender equality. The division also leads on provincial interests related to national defence and foreign affairs. This division also supports provincial participation in the Council of the Federation (COF).

- The Trade Policy Division represents the province's interests in interprovincial and international trade agreements. This includes the negotiation, ratification, and implementation of each agreement. The division is also responsible for providing trade analysis and advice relating to obligations under relevant domestic and international trade agreements. This division also supports provincial participation in the Atlantic Trade and Procurement Partnership (ATPP) and Committee on Internal Trade (CIT).

Staff and Budget

As of March 31, 2024, the Secretariat had a staff complement of 17 (ten female and seven male), and a budget of approximately \$2,066,400.

Vision

The Secretariat envisions a strong, self-reliant Newfoundland and Labrador advancing its best interests with governments in Canada and abroad.

Mandate

In keeping with **The Intergovernmental Affairs Act**, the Secretariat provides strategic policy advice, analysis, and support to the Premier, ministers, and departments on intergovernmental and trade policy issues, while building and strengthening relationships with other sovereign governments and international entities to advance provincial interests.

Lines of Business

The Secretariat's primary lines of business include:

Intergovernmental Policy Advice: The Secretariat is responsible for monitoring and analyzing social, fiscal, economic, resource and constitutional policy matters in order to formulate and provide policy analysis and advice on priority issues for the Province, as well as the development of government's intergovernmental strategy and agenda.

Promotion of the Province's Interests: The Secretariat builds relationships with other governments and international entities to advance the Province's interests. The Secretariat advocates for Newfoundland and Labrador at bilateral, multilateral, regional and international intergovernmental meetings, and conferences to present and promote Newfoundland and Labrador's positions on matters of importance to this province. The Secretariat further promotes the Province's interests by assisting departments in their participation in intergovernmental meetings and their negotiation of intergovernmental agreements.

Support and Coordination: The Secretariat coordinates and provides support for interdepartmental initiatives that have intergovernmental implications for the Province.

Highlights and Partnerships

Intergovernmental Engagement

To encourage regional collaboration among the Atlantic Provinces, the Secretariat supported the Premier through several CAP meetings in 2023, including an in-person meeting in Charlottetown, Prince Edward Island (PEI) on February 19 and 20, and an additional in-person meeting in Mill River, PEI on June 11 and 12.

Additionally, virtual meetings were held in May and June with the Honourable Steven Guilbeault, Minister of Environment and Climate Change, where Atlantic Premiers discussed the implications of the implementation of the Federal Clean Fuel Regulations in the region.

On December 11, 2023, the final virtual CAP meeting of the year took place with an agenda aimed at discussing progress made on 2023 priorities, including the Atlantic Health Accord, housing, and infrastructure. Beginning in January 2024, Newfoundland and Labrador assumed the role of Chair for CAP. The Secretariat provided support to the Premier in his capacity as Chair, as well as at the officials' level through both Senior Officials and Management-level working groups. Premier Furey hosted a virtual CAP meeting on February 28, 2024, focused on healthcare, infrastructure, housing, immigration, fisheries and other areas of shared interest and mutual opportunity.

2023 also saw Newfoundland and Labrador assume the role of provincial lead for the Atlantic Growth Strategy (AGS), a collaborative initiative of the Atlantic Provinces and the federal government aimed at accelerating the growth of Atlantic Canada's economy, following the summer Senior Leadership Committee meeting from July 17 to 18, 2023, hosted in Moncton, New Brunswick. As part of this work, the Secretariat supported important discussions around enabling continued population growth and workforce development, enhancing productivity and competitiveness, energy development

opportunities and accelerating the transition to a net-zero economy. Atlantic Premiers and federal Ministers ultimately agreed to the renewal of the AGS.

The Secretariat also facilitated Premier Furey's engagement in several COF meetings with Canada's Premiers. This included a virtual meeting between Premiers and the Canadian Association of Chiefs of Police on April 21, 2023, to build on Premiers' commitment to strengthen Canada's bail system to better protect the public, and create safer conditions for Canada's emergency responders. Premiers also participated in a call on June 2, 2023, in preparation for their annual meeting. The Secretariat also supported Premier Furey's participation in the annual meeting of Canada's Premiers in Winnipeg, Manitoba on July 10-12, 2023, which focused on supporting strong communities and economic growth, as well as a COF Premiers' meeting and Health Summit in Halifax, Nova Scotia on November 5-6, 2023, which focused on affordability, housing, strategic infrastructure, health and the role innovation can play in improving Canada's health care systems.

In addition, the Secretariat supported the Premier's participation in bilateral meetings with other Premiers to discuss a range of issues of mutual interest, from health care to housing to energy. For example, in November 2023, Newfoundland and Labrador hosted Premier David Eby of British Columbia, where the Premiers signed a Statement of Co-operation, agreeing to work together to advance clean-energy solutions that will deliver good jobs and tackle the climate crisis.

In order to both promote Newfoundland and Labrador's priorities and encourage federal collaboration, the Province also met bilaterally with a number of federal representatives. This included meetings with Minister Sean Fraser, Minister Jonathan Wilkinson and Minister François-Philippe Champagne, which provided opportunities to advocate for the Province's priorities in areas such as energy, critical minerals, infrastructure and housing. The Secretariat also supported a meeting with Prime Minister Justin Trudeau

during the Canada-European Union Summit, which was held in St. John's in November 2023. The Secretariat also prepared correspondence to the Prime Minister and federal ministers addressing key provincial priorities, including the federal carbon tax, defence investments in 5 Wing Goose Bay, equalization, fisheries issues, immigration, and critical infrastructure, including Marine Atlantic, among other pressing issues.

Continued Engagement with International Partners

During the reporting period, the Secretariat continued to advance collaboration with international partners on shared priorities, including but not limited to:

- Supporting the Premier in a Provincial Mission to Rotterdam from May 7 to 10, 2023. The mission focused on promoting the province's clean energy resources, opportunities for supplying green hydrogen to Europe and strengthening ties with the Port of Rotterdam while attending the 2023 World Hydrogen Summit. The mission culminated in the signing of a Memorandum of Understanding between Newfoundland and Labrador and the Port of Rotterdam to cooperate and explore opportunities in the area of green hydrogen and hydrogen technologies.
- Supporting the Premier as he met with more than 20 European Union (EU) Ambassadors and Heads of Mission to Canada in Ottawa on May 11, 2023. This meeting, hosted by the Ambassador of the EU to Canada, provided an opportunity to highlight Newfoundland and Labrador's long-standing economic and cultural ties with Europe, along with ongoing industrial activity in the province increasingly important to the EU, particularly as it relates to investment in clean hydrogen development.
- Supporting the Premier in a Provincial Mission to Los Angeles from June 15 to 17, 2023. The mission focused on developing relationships with major film studios, showcasing Newfoundland and Labrador as a filming destination and promoting the Province's new All-Spend tax incentive.

- Supporting the Premier in a Provincial Mission to Boston for the BIO International Convention from June 4 to 7, 2023. The conference facilitated opportunities to engage with industry leaders in bioscience, health, and life sciences, and highlighted the economic impact of these sectors on the Region.
- Supporting the Premier in the meeting of Southeastern United States and Canadian Provinces (SEUS-CP) hosted by the Province in St. John's from July 23 to 25, 2023. This was Newfoundland and Labrador's first time hosting the conference since 2009, which focused on clean energy adoption, sustainable transportation, port modernization and asset monitoring and observation. Delegations from Alabama, Georgia, Mississippi, North Carolina, Tennessee, Québec, Ontario, New Brunswick, Nova Scotia and Prince Edward Island were in attendance.
- Supporting the Premier in a meeting of New England Governors and Eastern Canadian Premiers (NEG-ECP) hosted in Québec City, Québec from September 24 to 25, 2023. The two-day conference focused areas of collaboration around the green economy, including critical minerals, green hydrogen, sustainable mobility, and electrification.
- Supporting the Premier in a Provincial Mission to London and Dubai from January 31 to February 8, 2024. The London portion of the mission focused on promoting Newfoundland and Labrador tourism opportunities, while the Dubai portion focused on the Premier's participation in an Atlantic health care recruitment event, exploring potential business partnerships and post-secondary education expansion.
- Supporting the Premier in a Provincial Mission to Washington and Boston from March 5 to 10, 2024. The mission focused on strengthening Newfoundland and Labrador-U.S. relations and promoting the province's energy resources and seafood industry.

The Secretariat also supported the Premier, Ministers, the Provincial Protocol Office and the Lieutenant-Governor's Establishment during diplomatic visits to the province throughout the reporting period. The Province hosted:

- His Excellency Urban Ahlin, Ambassador of Sweden to Canada, His Excellency Roy Eriksson, Ambassador of Finland to Canada, Her Excellency Hanne Fugl Eskjær, Ambassador of Kingdom of Denmark to Canada, His Excellency Jon Elvedal Fredriksen, Ambassador of Norway to Canada and His Excellency Hlynur Guðjónsson, Ambassador of Iceland to Canada.
- His Excellency Guðni Jóhannesson, President of the Republic of Iceland to Canada, whose program included discussions about strengthening Canada-Iceland relations, the blue economy, the green transition, health services, and North-North engagement.
- His Excellency Dr. Khalid bin Rashid Al Mansouri, Ambassador of the State of Qatar to Canada, whose program included discussions on Newfoundland and Labrador-Qatar relations.
- Her Excellency Hanne Fugl Eskjær, Ambassador of Kingdom of Denmark to Canada, whose program included discussions on the green transition, wind, hydrogen, and carbon capture utilization and storage.
- Her Excellency Esra Demir, Ambassador of the Republic of Türkiye to Canada, whose program included discussions about historical ties, the official unveiling of the Turkish Gallipoli Monument in St. John's and Newfoundland and Labrador-Türkiye relations.

Domestic and International Trade Policy

With a number of ongoing domestic and international trade negotiations, each intended to expand the number of economic opportunities for Newfoundland and Labrador, the Secretariat continued to lead, advocate, and negotiate best outcomes for the province.

Within the Atlantic region, the Province's interests were represented under CAP through the ATPP and the Atlantic Joint Office of Regulatory Affairs and Service Effectiveness.

On trade within Canada, the Secretariat actively led and engaged on work surrounding the Canadian Free Trade Agreement (CFTA), which is responsible for facilitating trade as well as reducing regulatory barriers across provinces and territories. The Secretariat chaired the Regulatory Reconciliation and Cooperation Table's (RCT's) Administrative Review Working Group. The Secretariat also participated in a number of working groups intended to address and promote internal trade under the CFTA, including the Internal Trade Representatives Table, the Communications Working Group, the Financial Services Chapter Working Group, the Dispute Resolution Working Group, the RCT and the Procurement Committee. Participation in these committees and working groups were in addition to representing the Province on the Internal Trade Secretariat Corporation's Board of Directors.

Work on internal trade supports the Premier as the Minister for Intergovernmental Affairs on matters related to the Committee on Internal Trade (CIT), including incorporating new rules on cannabis into the CFTA, working to finalize the financial services chapter, and other initiatives aimed at opening markets within the country. While there was no CIT meeting in 2023, officials continued to work on various initiatives to improve the CFTA and internal trade within Canada.

The Premier was supported in his hosting of the annual meeting of the Southeastern United States – Canadian Provinces (SEUS-CP) trade alliance in St. John's from July 23 to 25, 2023, which aims to enhance trade and investment through promoting business partnerships across Canada and the United States. Key topics for the conference included clean energy adoption, sustainable transportation, port modernization and asset monitoring and observation.

At the international level, the Secretariat continued to work towards providing Newfoundland and Labrador companies with a competitive trade advantage by advocating for provincial interests in international trade agreements and negotiations.

International agreements that are crucial to Newfoundland and Labrador's market access include the Canada-United States-Mexico Agreement (CUSMA), the Canada-European Union Comprehensive and Economic Trade Agreement (CETA), the Comprehensive and Progressive Trans-Pacific Partnership, and World Trade Organization. The Secretariat continues to advocate for provincial interests through various joint committees under CETA, such as the environment and the alcohol and spirits committees. Under all agreed trade agreements, there were sustained consultations where the Secretariat was engaged.

Ongoing trade negotiations required identification of issues of interest to the Province, collaborating with other provincial departments and provincial/territorial partners when appropriate, and ultimately negotiating for positions favorable to the short and long term economy of the province, including on sensitive issues. The Secretariat was engaged in the negotiations for the Canada-UK Free Trade Agreement and the Canada-India Foreign Investment Promotion and Protection Agreement before they were paused. The Secretariat continues to engage in the negotiations for the Canada-Indonesia Comprehensive Economic Partnership Agreement; the Canada-ASEAN Free Trade Agreement, and the Canada-Ecuador Free Trade Agreement. In addition to these negotiations, the Secretariat also represented Provincial interests on international trade issues at the Federal-Provincial-Territorial Committee on International Trade (C-Trade).

Report on Performance

Issue One – Progressing the Province’s Strategic Intergovernmental Priorities

The Secretariat is dedicated to progressing Newfoundland and Labrador’s strategic intergovernmental priorities through constructive engagements with the federal government and other provincial and territorial governments across Canada, as well as other sovereign governments worldwide. This involves promoting provincial objectives through various intergovernmental engagements and forums, such as the Council of the Federation, Council of Atlantic Premiers, First Ministers’ Meetings, New England Governors and Eastern Canadian Premiers, and Atlantic Growth Strategy and other multilateral, bilateral, and regional engagements.

Under the **Intergovernmental Affairs Act**, the Minister for Intergovernmental Affairs is required to be a party to the negotiation and execution of all intergovernmental agreements between the Government of Newfoundland and Labrador and other sovereign governments. The Secretariat plays a fundamental role in providing assistance and support to government departments during these negotiations and assessing agreements to ensure they are consistent with the government’s intergovernmental policies and priorities.

The Secretariat recognizes continued and effective intergovernmental collaboration is essential to securing a healthier province in all areas, our economy, our finances, and our people. Working closely with other provincial and territorial governments, as well as the federal government, on economic, health and well-being supports, and funding opportunities is fundamental to securing a bright future for Newfoundland and Labrador.

By March 31, 2026, the Secretariat will have supported the progression of Government's strategic economic and social intergovernmental priorities.

By March 31, 2024, the Secretariat will have supported the progression of Government's strategic intergovernmental priorities.

One area of focus was the recruitment of internationally educated health care professionals and foreign credential recognition. Efforts included securing federal funding for the Province through the federal Foreign Credential Recognition Program to facilitate the recruitment of Registered Nurses to Newfoundland and Labrador from India, as well

As the Provincial Government's primary division responsible for negotiating and executing trade agreements, the Secretariat's Trade Policy Division plays a central role in stimulating a strong economy. Trade policy encompasses the objectives, regulations, agreements, and various arrangements that govern trade relations between governments and jurisdictions. Trade policy strives to minimize and eliminate obstacles

to the unrestricted movement of individuals, commodities, services, and investments between regions.

The Secretariat is committed to positioning Newfoundland and Labrador to leverage opportunities to access new markets around the globe, decrease barriers to interprovincial trade within Canada to ensure Newfoundland and Labrador can respond to emerging threats and opportunities effectively.

By March 31, 2026, the Secretariat will have supported the progression and protection of the Province's domestic and international trade priorities.

Opportunities and Challenges

In the lead up to the United States (US) Presidential Election in November 2024, the Province will continue to reiterate the significance of Canada-US relations and to highlight the opportunities available in Newfoundland and Labrador.

Premier Furey led a mission to Washington and Boston in March 2024 aimed at strengthening this province's bilateral economic ties in United States, including exploring new market opportunities, and promoting Newfoundland and Labrador's capabilities. The Premier emphasized to Canada's Ambassador to the US the need to create awareness about the deep and highly integrated relationship provinces and territories have with US states, as well as a greater understanding of the jurisdictional responsibilities of Premiers.

As the province's largest export and import jurisdiction in 2023, deepening relations with the US is of paramount importance. The year ahead will bring opportunities to engage with US colleagues during the New England Governors – Eastern Canadian Premiers (NEG-ECP) conference, being held in Boston, Massachusetts. Newfoundland and Labrador will assume Chair of NEG-ECP and will host governors and premiers in the province in 2025.

The Province is also expected to move forward with plans to launch its first international office in the US. Efforts to tackle the global challenges of energy security and climate change require strong partnerships that cut across national borders. Newfoundland and Labrador can be a valuable partner for the US in confronting and overcoming these challenges, particularly with our abundance of renewable energy and critical minerals.

A strong and safe Canada, and North America, requires provincial and territorial partnership. Newfoundland and Labrador continues to play an important role in the

security and sovereignty of Canada's Arctic and supports allies via the North Atlantic Treaty Organization (NATO) and the North American Aerospace Defense Command (NORAD) given its strategic location. Infrastructure investments as a result of NORAD modernization are of significant interest to the Province in order to maintain and strengthen Canada, particularly as Russia moves forward with militarizing the Arctic region.

Like other provinces and territories, Newfoundland and Labrador continued to experience escalating demands across the full housing continuum. The Province responded with the highest level of provincial investment in housing in decades; however, more must be done. While the federal government put forward federal funding for housing, the Province has been challenged in accessing it as a smaller jurisdiction competing against major population centres in application-based funding pots. The Atlantic Provinces continue to work closely together to develop regional solutions that respond to the unique needs and realities of our provinces while also advocating for flexible, long-term funding to ensure safe, accessible, and affordable housing for all.

In addition to ongoing housing pressures, Newfoundland and Labrador, alongside all provinces and territories, maintains the federal government must introduce a successor to the Investing in Canada Infrastructure Program, that concluded March 31, 2023. Adequate, predictable long-term funding is essential to multi-year infrastructure planning.

These and other long-standing and emerging challenges and opportunities, such as a rapidly changing climate, are driving higher levels of overall engagement by the Province with other provinces and territories, the federal government, and foreign governments. The Intergovernmental Affairs Secretariat will continue to actively participate in and support engagements across all areas of government to promote and secure the Province's interests.
