*Farm registration is an eligibility requirement for the Vegetable Transplant Program. To register your farm, contact your regional Agriculture Development Officer (ADO). A complete listing of ADO regions and contact information can be found in Appendix A of the Program Guide.

Order Selection

- Transplants will be delivered as two separate orders and will be available for pick-up from the last week of May through to the second week of June 2026.
- Applicants may choose to order transplants for pick-up the last week of May (Order # 1), through to the second week of June (Order # 2), or both weeks.
- Vegetable transplant trays have 200 cells and cost \$2.00 each
 - note that each tray may not yield 200 transplants, as 100 per cent germination cannot be guaranteed.
- Asparagus will **only** be available for pick-up during Order #2
 - asparagus transplants are one-year plugs and cost \$0.05 each.
