- Detailed project proposal, including budget. The proposal must include a description and background of the applicant, the goal of the project, when and where the activities will take place, project rationale, how the project will be executed and how it meets the objectives of the SMSP.

The extent of information required will be dependent on the complexity and size of the project. For larger, more complex projects, a detailed business plan and/or market study may be required.
