

## Residential Tenancies Tribunal

### Introduction

1. Hearing was called at 9:15 a.m. on 27-April-2022.
2. The applicant, [REDACTED], represented by [REDACTED], hereinafter referred to as “the landlord” attended by teleconference.
3. The respondent, [REDACTED], hereinafter referred to as “the tenant” did not attend.

### Preliminary Matters

4. The tenant was not present or represented at the hearing and there was no number provided with the application therefore, I was unable to reach her by telephone at the start of the hearing. This Tribunal’s policies concerning notice requirements and hearing attendance have been adopted from the *Rules of the Supreme Court, 1986*. According to Rule 29.05(2)(a) respondents to an application must be served with claim and notice of the hearing 10 clear days prior to the hearing date and, where the respondent fails to attend the hearing, Rule 29.11(1) states that the hearing may proceed in the respondent’s absence so long as she has been properly served. The landlord submitted an affidavit (LL#01) with their application stating that they had served the tenant with notice of the hearing, by prepaid registered mail on 10-March-2022 and the tracking shows it was received on 16-March-2022. As the tenant was properly served, and as any further delay in these proceedings would unfairly disadvantage the landlord, I proceeded with the hearing in her absence.

### Issues before the Tribunal

5. The landlord is seeking vacant possession of the rental premises.

### Legislation and Policy

6. The jurisdiction of the Director of Residential Tenancies is outlined in sections 46 and 47 of the *Residential Tenancies Act, 2018*.

7. Also relevant and considered in this decision is the following section of the *Residential Tenancies Act, 2018*: Section 18: Notice of termination of rental agreement.

## Issue 1: Vacant Possession of the Rental Premises

### Relevant Submissions

8. The landlord said that they have a written monthly rental agreement with the tenant. She took possession of the apartment on 01-April-2021. Her rental period is from the 1<sup>st</sup> day of the month until the last and \$810.00 rent is due in full on the first day of each month. She said that the tenant paid a security deposit of \$400.00 on 25-March-2021 and they are still in possession of that deposit.
9. The landlord submitted a termination notice (LL#02), it is a Section 18 notice that was dated and signed for 16-December-2021 with a termination date of 31-March-2022. The landlord said that they sent the notice by prepaid registered mail on 20-December-2021 and the tracking number indicates that it was received on 24-December-2021.
10. The landlord is seeking an order of vacant possession.

### Analysis

11. According to Section 18 of the *Residential Tenancies Act, 2018*:

#### *Notice of termination of rental agreement*

*18. (2) A landlord shall give the tenant notice that the rental agreement is terminated and the tenant is required to vacate the residential premises*

*(a) not less than 4 weeks before the end of a rental period where the residential premises is rented from week to week;*

*(b) not less than 3 months before the end of a rental period where the residential premises is rented from month to month; and*

*(c) not less than 3 months before the end of the term where the residential premises is rented for a fixed term.*

.....

*(9) In addition to the requirements under section 34, a notice under this section shall*

*(a) be signed by the person providing the notice;*

*(b) be given not later than the first day of a rental period;*

*(c) state the date, which shall be the last day of a rental period, on which the rental agreement terminates and the tenant intends to vacate the residential premises or the date by which the tenant is required to vacate the residential premises; and*

*(d) be served in accordance with section 35.*

12. The termination notice submitted by the landlord (LL#02) meets the requirements of the *Act* and is a valid notice.
13. The termination notice is valid and the tenant should have moved on 31-March-2022.

#### **Summary of Decision**

14. The tenant shall vacate the premises immediately.
15. The tenant shall pay to the landlord any costs charged to the landlord, by the Office of the High Sherriff, should the landlord be required to have the Sheriff enforce the attached Order of Possession.
16. The landlord is granted an Order of Possession.
