

## **Residential Tenancies Tribunal**

### **Introduction**

1. Hearing was called at 9:16 a.m. on 11-October-2022.
2. The applicant, [REDACTED], represented by [REDACTED] [REDACTED], hereinafter referred to as “the landlord” attended by teleconference.
3. The respondent, [REDACTED], hereinafter referred to as “the tenant” did not attend.

### **Preliminary Matters**

4. The tenant was not present or represented at the hearing and the phone number provided was not in service. This Tribunal’s policies concerning notice requirements and hearing attendance have been adopted from the *Rules of the Supreme Court, 1986*. According to Rule 29.05(2)(a) respondents to an application must be served with claim and notice of the hearing 10 clear days prior to the hearing date and, where the respondent fails to attend the hearing, Rule 29.11(1) states that the hearing may proceed in the respondent’s absence so long as she has been properly served. The landlord submitted an affidavit with their application stating that they had served the tenant with notice of the hearing, by pre-paid registered mail, on 08-September-2022. I used the tracking number and it indicates that the package was never picked up. It is our policy to consider a package sent by pre-paid registered mail served after 5 days. As the tenant was properly served, and as any further delay in these proceedings would unfairly disadvantage the landlord, I proceeded with the hearing in her absence.

### **Issues before the Tribunal**

5. The landlord is seeking:
  - Vacant possession of the rental premises
  - Hearing expenses reimbursed \$20.00

### **Legislation and Policy**

6. The jurisdiction of the Director of Residential Tenancies is outlined in sections 46 and 47 of the *Residential Tenancies Act, 2018*.
7. Also relevant and considered in this decision is the following section of the *Residential Tenancies Act, 2018*: Section 18: Notice of termination of rental agreement.

### **Issue 1: Vacant Possession of the Rental Premises**

#### **Relevant Submissions**

8. The landlord submitted a written rental agreement (LL#02) which they hold with the tenant. The tenant moved in on 13-March-2020 and signed a term agreement from 01-April-2020 until 31-March-2021, they later signed another term agreement from 01-June-2021 until 30-May-2022, and currently they are in a monthly agreement. The tenant pays \$810.00 rent on the first day of each month; utilities are not included. The tenant paid a security deposit of \$400.00 on 11-March-2020, the landlord is still in possession of the full deposit.
9. The landlord submitted a termination notice (LL#03), it is a Section 18 notice that was dated and signed for 29-April-2022 with a termination date of 31-July-2022. The landlord said that the Building Caretaker hand delivered the notice on 29-April-2022. The landlord also provided a signed acknowledgement, from the tenant, confirming she received the notice (LL#03).
10. The landlord is seeking an order of vacant possession.

#### **Analysis**

11. According to Section 18 of the *Residential Tenancies Act, 2018*:

##### ***Notice of termination of rental agreement***

***18. (2) A landlord shall give the tenant notice that the rental agreement is terminated and the tenant is required to vacate the residential premises***

- (a) not less than 4 weeks before the end of a rental period where the residential premises is rented from week to week;***
- (b) not less than 3 months before the end of a rental period where the residential premises is rented from month to month; and***
- (c) not less than 3 months before the end of the term where the residential premises is rented for a fixed term.***

.....

***(9) In addition to the requirements under section 34, a notice under this section shall***

- (a) be signed by the person providing the notice;***
- (b) be given not later than the first day of a rental period;***

*(c) state the date, which shall be the last day of a rental period, on which the rental agreement terminates and the tenant intends to vacate the residential premises or the date by which the tenant is required to vacate the residential premises; and*

*(d) be served in accordance with section 35.*

12. The termination notice submitted by the landlord (LL#03) meets the requirements of the Act and is a valid notice.
13. The termination notice is valid and the tenant should have moved on 31-July-2022.

#### **Decision**

14. The landlord's claim for an Order of Possession succeeds.

#### **Issue 2: Hearing expenses reimbursed \$20.00**

15. The landlord submitted the receipt for \$20.00 for the cost of the hearing (LL#04) and pursuant to policy 12.01, is entitled to reimbursement of that cost from the tenant.

#### **Summary of Decision**

16. The tenant shall vacate the premises immediately.
17. The tenant shall pay to the landlord any costs charged to the landlord, by the Office of the High Sheriff, should the landlord be required to have the Sheriff enforce the attached Order of Possession.
18. The tenant shall reimburse the landlord \$20.00 for their hearing expenses.
19. The landlord is granted an Order of Possession.
