Introduction

1. Hearing was called at 1:47 p.m. on 26-March-2024.
2. The applicant, [REDACTED] represented by [REDACTED] hereinafter referred to as "the landlord", attended by teleconference.
3. The respondent, [REDACTED] hereinafter referred to as "the tenant" attended by teleconference. Also present was [REDACTED] a support person.

Preliminary Matters

4. The landlord submitted an affidavit with their application stating that they served the tenant with the notice of hearing personally at the residential premises on 14-March-2024 (LL#1). The respondent confirmed receiving the document on that date. In accordance with the *Residential Tenancies Act, 2018* this is good service.
5. There is a written month-to-month rental agreement which commenced on 1-April-2017. Rent is \$422.95 per month paid by [REDACTED] due on the 1st of each month. A security deposit of \$225.00 was paid on 1-April-2017 and is in the landlord's possession.

Issues before the Tribunal

6. The landlord is seeking:
 - An order for vacant possession of the rented premises

Legislation and Policy

7. The jurisdiction of the Director of Residential Tenancies is outlined in sections 46 and 47 of the *Residential Tenancies Act, 2018*.
8. Also, relevant and considered in this decision is the following section of the *Residential Tenancies Act, 2018*: Section 18: Notice of termination of rental agreement.

Issue # 1: Vacant Possession of the Rented Premises

Relevant Submissions

9. The landlord submitted a copy of a termination notice issued to the tenant on a *Landlord's Notice to Terminate – Standard* form (LL#2). The notice was dated for 31-August-2023 under Section 18: Notice of termination of rental agreement to vacate the premises on 30-November-2023.

Analysis

10. The notice was served under Section 18 of the *Residential Tenancies Act, 2018* which states:

Notice of termination of rental agreement

18. (2) A landlord shall give the tenant notice that the rental agreement is terminated and the tenant is required to vacate the residential premises

(a) not less than 4 weeks before the end of a rental period where the residential premises is rented from week to week;

(b) not less than 3 months before the end of a rental period where the residential premises is rented from month to month; and

(c) not less than 3 months before the end of the term where the residential premises is rented for a fixed term.

.....

(9) In addition to the requirements under section 34, a notice under this section shall

(a) be signed by the person providing the notice;

(b) be given not later than the first day of a rental period;

(c) state the date, which shall be the last day of a rental period, on which the rental agreement terminates and the tenant intends to vacate the residential premises or the date by which the tenant is required to vacate the residential premises; and

(d) be served in accordance with section 35.

11. The termination notice submitted by the landlord meets the requirements of not less than 3 months before the end of a rental period where the residential premises is rented month-to-month. The landlord stated that the termination notice was posted to the tenants' door on 31-August and the tenant confirmed receipt of the notice on that date. In accordance with the *Residential Tenancies Act, 2018* as stated above, the termination notice meets the requirements of the *Act* and is a valid notice.

12. I find that the tenant should have vacated the premises on 30-November-2023.

Decision

13. The landlord's claim for an order of vacant possession succeeds.

Summary of Decision:

14. The termination notice is a valid notice.
15. The tenant shall vacate the premises immediately.
16. The landlord will be awarded an Order of Possession.
17. The tenant shall pay to the landlord any costs charged to the landlord by the Office of the High Sheriff should the landlord be required to have the Sheriff enforce the attached Order of Possession.
