Introduction

1. Hearing was held on 5-August-2024 at 1:44 pm via teleconference..
2. The applicant, [REDACTED], hereinafter referred to as the landlord, was in attendance. The landlord's agent, [REDACTED], [REDACTED] was also in attendance and represented the landlord.
3. The respondent, [REDACTED], hereinafter referred to as the tenant, was in attendance.

Preliminary Matters

4. The landlord submitted an affidavit (LL#1) with their application stating that they had served the tenant with notice of the hearing via registered mail. The tenant confirmed receipt of the documents on July 19, 2024. In accordance with the Residential Tenancies Act, this is considered good service.
5. The tenant has resided on the property for more than 8-years. The rental agreement is described as a written month-to-month agreement and a copy (LL#2) was provided, with rent in the amount of \$1300.00 per month paid in 2 installments on the 1st and 15th of each month.

Issues before the Tribunal

6. The landlord is seeking an Order for Vacant Possession.

Legislation and Policy

7. The jurisdiction of the Director of Residential Tenancies is outlined in sections 46 and 47 of the *Residential Tenancies Act, 2018* (the *Act*).
8. Also considered and referred to in this decision are sections 18(2), 18(9), and 34 of the *Act*, reproduced below:

Notice of termination of rental agreement

18. ...

(2) A landlord shall give the tenant notice that the rental agreement is terminated and the tenant is required to vacate the residential premises

- (a) not less than 4 weeks before the end of a rental period where the residential premises is rented from week to week;
- (b) not less than 3 months before the end of a rental period where the residential premises is rented from month to month; and
- (c) not less than 3 months before the end of the term where the residential premises is rented for a fixed term.

...

(9) In addition to the requirements under section 34, a notice under this section shall

- (a) be signed by the person providing the notice;
- (b) be given not later than the first day of a rental period;
- (c) state the date, which shall be the last day of a rental period, on which the rental agreement terminates and the tenant intends to vacate the residential premises or the date by which the tenant is required to vacate the residential premises; and
- (d) be served in accordance with section 35.

Requirements for notices

34. A notice under this Act shall

- (a) be in writing in the form prescribed by the minister;
- (b) contain the name and address of the recipient;
- (c) identify the residential premises for which the notice is given; and
- (d) state the section of this Act under which the notice is given.

Issue 1: Vacant Possession

- 9. In order to receive an order for vacant possession, a landlord must issue a valid termination notice. To be valid, a termination notice must comply with all relevant sections of the *Act*. The landlord submitted LL#3, a termination notice that was served on the tenant in person on 28-April-2024 with a termination date of 31-July-2024.
- 10. LL#3 is in writing in the form prescribed by the minister. It contains the name and address of the recipient. It identifies the residential premises for which it was given. It states it is issued under s. 18 of the *Act*. It therefore complies with s. 34.

11. LL#3 was signed by the landlord's agent who delivered the notice on 28-April-2024, was not less than 3-months before the end of the rental period after the notice was served and it states the date on which the rental agreement is to terminate. It was served personally in accordance with s. 35(2)(a) of the *Act*. It therefore complies with s. 18(9).
12. LL#3 complies with all relevant sections of the *Act* and is therefore valid.
13. The tenant noted that he is not trying to be difficult, and he had not vacated by 31-July-2024 due to medical reasons and he has been looking to obtain alternate housing for himself and his child.

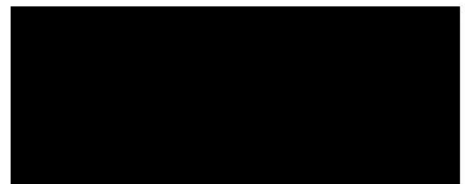
Decision

14. A valid termination notice was issued which gives a move out date of 31-July-2024. The rental agreement terminated on that date. Insofar as the tenant is still residing at the premises, they are doing so illegally.
15. The landlord's application for an order of vacant possession succeeds.

Summary of Decision

16. The tenant shall vacate the premises immediately.
17. The tenant shall pay to the landlord any costs charged to the landlord, by the Office of the High Sherriff, should the landlord be required to have the Sheriff enforce the attached Order of Possession.
18. The landlord is granted an order of possession.
