		403 - Facility Free of Pests (Vermin and Insects)	Corrected During Inspection Evidence of rodent activity in premises. Pest Control Operator in place. Continue to protect food in rodent proof containers.
	Non-Critical Item(s)	506 - Equipment in good repair, cleaned and sanitized	Hot holding unit used for service requires repair or replacement. Continue to use other stand-up unit and oven to keep hot foods at proper temperature in interim. Faucet on 3-compartment sink requires repair or replacement due to apparent leaking. All surfaces including sink faucets and areas must be kept smooth, impervious and easy-to-clean.
		702 - Non-food contact surfaces properly constructed, in good repair and clean	Damaged areas of walls and ceilings require repair as to be smooth, impervious and easy-to-clean.
		704 - Adequate protection from vermin and insect pests	Continue to investigate potential pest entry points and repair to prevent rodent entry.

Pest control operator in place. Continue to protect food in rodent-proof containers. Continue to sanitize and disinfect surfaces with adequate intervals/methods to prevent potential hazards. Continue with regular/ routine floor maintenance/ cleaning as to monitor rodent activity and for sanitation purposes. Continue to monitor and remediate in approved, safe technique.</p>
	Non-Critical Item(s)	704 - Adequate protection from vermin and insect pests	Continue to investigate potential pest entry points and repair to prevent rodent entry.
Food - Routine Inspection Dec 17, 2024	Critical Item(s)	403 - Facility Free of Pests (Vermin and Insects)	<p>Corrected During Inspection</p> <p>New pest control operator in place. Rodent proof containers used to protect foods. Food surface disinfectant/ procedures in place. Evidence of rodent activity observed in other areas- Deep clean required (behind and under equipment)- schedule required for cleaning behind and under equipment.</p>
	Non-Critical Item(s)	506 - Equipment in good repair, cleaned and sanitized	Plumbing for soup kettles leaking. This requires repair or replacement as to prevent associated potential hazards.
		604 - Toilet facilities: properly constructed, supplied and cleaned	Paper towel and liquid soap present- dispensers required.

Food - Routine Inspection Dec 17, 2024	Type Non-Critical Item(s)	Code - Description	Apparent water damage on ceiling near dish washing area- investigation and repair required to prevent potential hazards.
		704 - Adequate protection from vermin and insect pests	Screens required for windows, for event of opening, to prevent potential rodent/ pest entry,
		802 - Working dishwasher temperature and pressure gauge	Dish washer requires investigation- "error/maintenance" code indicated. Ensure that dish washer is reaching proper sanitization temperature. In interim, 3-compartment sink method required for dishes/ equipment (disposable being used for service-ware).
Food - Annual Inspection Mar 27, 2024	Critical Item(s)	403 - Facility Free of Pests (Vermin and Insects)	Evidence of rodent activity in premises. Pest control operator in place. Continue with remediation. Protect food/ disinfect surfaces with approved disinfectant in approved methods/ intervals. Sources of pest entry must be identified and remediated. Additional rodent proof containers required as damaged containers observed/ removed during inspection. Food/ food containers disposed of during time of inspection to control potential hazards. Cleaning/disinfection required today with approved/ safe technique. Additional pest control visits required. Flies in adjacent storage room require remediation.
	Non-Critical Item(s)	506 - Equipment in good repair, cleaned and sanitized	Damaged/ leaking areas require remediation in an approved, safe technique. Leak being repaired during time of inspection. Equipment adjacent to leak must not be used until after remediation/ disinfection.
		702 - Non-food contact surfaces properly constructed, in good repair and clean	Damaged/ leaking areas require remediation in an approved, safe technique. Leak being repaired during time of inspection. Cleaning/ disinfection required.
