Food - Annual Inspection Jan 21, 2026	Critical Item(s)	401 - Food Separated and Protected	residents must be prevented from having access to servery during food service. Recommend gate to prevent access. Salmon lane especially problematic. Any foods contaminated during these times MUST be discarded (incl items in fridge etc if fridge door is contaminated and opened)
	Non-Critical Item(s)	704 - Adequate protection from vermin and insect pests	extra door sweeps required as previously identified (all gaps to outside areas must be addressed. Extra pest control (pest lights)
Food - Routine Inspection Jul 09, 2025	Non-Critical Item(s)	702 - Non-food contact surfaces properly constructed, in good repair and clean	Steam kettle floor drain not draining properly - must be corrected
		704 - Adequate protection from vermin and insect pests	extra door sweeps on dry storage room door, double pedestrian door to outside (near loading bay) and double door from loading area to staff area as well as on the hydraulic stock lift. Extra pest control (pest light) required.

Oct 29, 2024	Non-Critical Item(s)	704 - Adequate protection from vermin and insect pests	extra door sweeps required on dry storage room(bottom of door), double pedestrian exit to outside near loading bays, and double door from loading area to staff back hall. Lifts in floor require better seals recommend extra pest control prevention (ie lights) installed (currently working on obtaining these)
