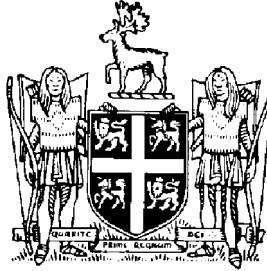

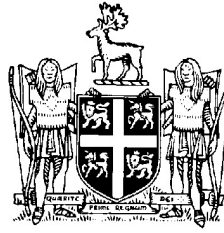

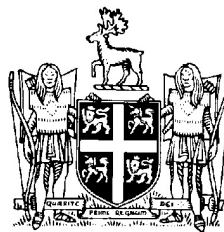

Short title	<b>1.</b> This Order may be cited as the <i>Wind Energy Land Reserve Order</i> .
Definitions	<p><b>2.</b> In this Order,</p> <p>(a) "available Crown lands" means Crown lands that have not been</p> <p style="padding-left: 40px;">(i) granted, leased or the subject of a licence or easement, or</p> <p style="padding-left: 40px;">(ii) otherwise lawfully set apart or alienated from the Crown;</p> <p>(b) "call for bids" means the process outlined in the Guidelines: Crown Land Call for Bids for Wind Energy Projects prepared by the Department of Industry, Energy and Technology; and</p> <p>(c) "Wind Energy Land Reserve" means Crown land reserved under section 3.</p>
Purpose	<b>3.</b> The Wind Energy Land Reserve is established to ensure that available Crown lands located within the area described in the Schedule are available for the purpose of the call for bids.
Term	<b>4.</b> The Wind Energy Land Reserve is established for a one year period.
Exception	<b>5.</b> Notwithstanding section 3, the minister may issue grants, leases, licences or easements in relation to Crown land included in the Wind Energy Land Reserve where the Crown land is required on an urgent basis for the public good.

All that piece or parcel of land containing approximately 1,663,815 hectares, more or less, as depicted on the Provincial Land Use Atlas.

(1.1) Notwithstanding paragraphs (1)(i) and (j), where ISO-14064-3 or ISO 14065 are amended, the previous version of the document may be complied with for a period of 3 years after the day on which the amended version of the document is published.

**2. (1) Subparagraph 7(4)(t)(i) of the regulations is amended by deleting the words "he or she" and substituting the words "the individual".**

**(2) Subparagraph 7(4)(t)(iii) of the regulations is amended by deleting the words "his or her" and substituting the words "the individual's".**

(d) site visits, where required under subsection (2.1);

(2.1) A site visit referred to in paragraph 2(d) is required in the following situations:

- (a) it is the initial verification of the industrial facility under these regulations or by the verification body;
- (b) at least 3 calendar years have passed since the verification body has verified an emissions report for the industrial facility;
- (c) in the last emissions report for the industrial facility, the verification body made a determination
  - (i) that a material discrepancy exists with respect to the reported greenhouse gas estimates, or
  - (ii) that the emissions report was not prepared in accordance with these regulations; or
- (d) the verification body is of the opinion that a site visit is required.

**7. Subparagraph 20(1)(b)(i) of the regulations is amended by deleting the words "he or she" and substituting the words "the minister".**

**8. (1) Subparagraph 20.1(3)(c)(i) of the regulations is amended by deleting the words "he or she" and substituting the words "the individual".**

(2) Subparagraph 20.1(3)(c)(iii) of the regulations is amended by deleting the words "his or her" and substituting the words "the individual's".
