

## **NEWFOUNDLAND AND LABRADOR REGULATION 58/25**

*Income and Employment Support Regulations (Amendment) No. 2  
under the  
Income and Employment Support Act  
(O.C. 2025-209)*

*(Filed July 24, 2025)*

**1. (1) Paragraph 2(c.1) of the *Income and Employment Support Regulations* is repealed and the following substituted:**

(c.1) "dependent" means a dependent of an applicant or recipient who is

- (i) a child under the age of 18 years, or
- (ii) a dependent student;

**(2) Section 2 of the regulations is amended by adding immediately after paragraph (h) the following:**

(h.1) "school-aged dependent" means a dependent referred to in subparagraph (c.1)(i) who, by December 31 in a year, will be 5 years of age or older;

**2. Subsection 19(5) of the regulations is amended by deleting the word "and" at the end of paragraph (c), deleting the period at the end of paragraph (d) and substituting a semi-colon and adding immediately after paragraph (d) the following:**

- (e) for a recipient with one or more school-aged dependents, an annual contribution towards school-related expenses in the amount of \$100 a year in respect of each school-aged dependent of the recipient; and
- (f) for a recipient who is 18 years of age or older but under 21 years of age who attends high school, an annual contribution towards school-related expenses in the amount of \$100 a year.

**3. (1) Paragraph 27(3)(a) of the regulations is repealed.**


**(2) Subsection 27(5) of the regulations is repealed and the following substituted:**

(5) Notwithstanding subsection (3), when determining the amount for expenses referred to in subsections (1) and (2) with respect to a deceased person who was a recipient of income support at the time of death, or during the 12-month period immediately before the time of death, an officer shall deduct only

- (a) any monies held in trust for the deceased person's expenses referred to in subsections (1) and (2); and
- (b) a death benefit from any source to which the estate of the deceased person is entitled.

**1. (1) Subsection 4(2) of the *Student Financial Assistance Regulations* is repealed and the following substituted:**

(2) Commencing August 1, 2025, financial assistance issued to a qualifying student shall be issued in the manner and amounts as follows:

- (a) first, subject to subsection (3), an amount of not more than \$420 per course in a non repayable Memorial University Tuition Relief Grant;
- (b) second, an amount of not more than \$120 per week of a period of study in student loan;
- (c) third,
  - (i) an amount of not more than \$120 per week of a period of study in a non repayable grant, or
  - (ii) where the qualifying student is enrolled in medical school at Memorial University of Newfoundland, an amount of not more than \$145 per week of a period of study in a non repayable grant; and
- (d) fourth, where the qualifying student is enrolled in medical school at Memorial University of Newfoundland, a further amount of not more than \$35 per week of a period of study in student loan.

**(2) Subsection 4(4) of the regulations is repealed and the following substituted:**

(4) Notwithstanding subsection (2), commencing August 1, 2025, where a qualifying student is enrolled in a program of study outside the province, financial assistance issued to the qualifying student shall be issued in an amount of not more than \$240 per week of a period of study in student loan unless the minister determines that

- (a) the qualifying student's program of study is not offered in the province;
- (b) the qualifying student is enrolled in graduate studies;
- (c) the qualifying student's program of study differs substantially from any program of study offered in the province;
- (d) the qualifying student does not meet the minimum entry requirement for the qualifying student's program of study in the province but meets the requirements for substantially the same program outside the province;
- (e) the qualifying student applied to do the qualifying student's program of study in the province but was denied entry due to limited spaces in that program;
- (f) the qualifying student received transfer credits toward advanced standing into the qualifying student's program of study, resulting in a reduced length of time for that program;
- (g) the qualifying student's partner
  - (i) has undertaken studies outside the province, and
  - (ii) meets a requirement under one or more of paragraphs (a) to (f); or
- (h) there is another reason that the minister considers to be appropriate.

**2. (1) Paragraph 6(1)(a) of the regulations is repealed and the following substituted:**

- (a) graduated from a program of study in the province that is not fewer than
  - (i) 80 weeks in duration, where the borrower commenced the program of study before August 1, 2025, or
  - (ii) 60 weeks in duration, where the borrower commenced the program of study on or after August 1, 2025;

**(2) Paragraph 6(1)(b) of the regulations is amended by deleting the word "and" at the end of that paragraph.**

**3. These regulations come into force on August 1, 2025.**
