A PROCLAMATION

WHEREAS by Our Proclamation dated the 15th day of September,  
2025, We did dissolve the Fiftieth General Assembly of Our Province  
of Newfoundland and Labrador;

AND WHEREAS it is Our Will and Pleasure to summon and call a
