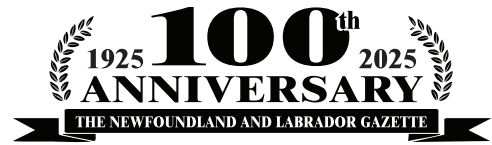

A PROCLAMATION

WHEREAS under section 128 of the *Constitution Act, 1867*, I, as Administrator in and for the Province of Newfoundland and Labrador, am authorized to administer the Oaths or Affirmations of Allegiance to His Majesty King Charles III to those persons elected to be Members of the House of Assembly in the General Election held on October 14th, 2025;

AND WHEREAS under section 5 of the *House of Assembly Accountability, Integrity and Administration Act*, I, as Administrator in and for the Province of Newfoundland and Labrador, am authorized to administer the Oaths or Affirmations of Office to those persons elected to be Members of the House of Assembly in the said General Election;

AND WHEREAS the said sections of the *Constitution Act, 1867* and the *House of Assembly Accountability, Integrity and Administration Act* further require that the persons declared elected as the Member for the District of Lewisporte - Twillingate and the Member for the District of Placentia West - Bellevue during the said General Election held on the said date must take their Oaths or Affirmations of Allegiance and Oaths or Affirmations of Office before they can take their seats in the House of Assembly;

NOW THEREFORE, I, the Administrator in and for the Province of Newfoundland and Labrador, do authorize and direct you, the said Kim Hawley George KC, Kimberley Hammond, and Bobbi Russell, or any of you, to request that those Members Elect gather in the House of Assembly Chamber on Tuesday, November 18th, 2025, at 10:00 o'clock in the morning in order to take their Oaths or Affirmations of Allegiance and Oaths or Affirmations of Office before me.
