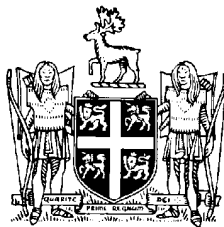

Amendment No.3, 2002, is to re-designate a portion of land

Residential to Mixed Development to allow for development
of a commercial nursery/greenhouse and associated retail
outlet.

The purpose of Development Regulations Amendment No. 3, 2002, is to re-zone the same portion of land currently zoned as Residential Medium Density to Commercial - General.

Municipal Plan Amendment No.4, 2002, is to re-designate a portion of land located Civic No. 426, Conception Bay Highway from Environment to Mixed Development to allow for development of a seaside café and information centre.

Development Regulations Amendment No. 4, 2002, is to re-zone the same portion of land currently zoned as Conservation to Mixed Development.
