MUNICIPALITIES ACT

TOWN OF GRAND FALLS-WINDSOR TRAFFIC REGULATIONS AMENDMENT NO.7

The Town of Grand Falls-Windsor Traffic Regulations are hereby amended by adding the following Regulation:-

- 18 (g) Trucks which have a registered mass weight in excess of 19,000 kilograms, shall not enter or exit Town from or to the south side road or the Trans Canada Highway except via Scott Avenue through interchange #20.

Notwithstanding the foregoing, trucks which have a registered mass weight in excess of 19,000 kilograms, with a terminus within Town must enter and exit Town through the nearest point to that terminus from Scott Avenue or the nearest point from the Trans Canada Highway whichever route is of the shortest distance.

Add the following to Schedule "A", Schedule of Fines of the Grand Falls-Windsor Traffic Regulations:-

- 18 (g) Operating a truck contrary to designated Route
