NOTICE OF REGISTRATION ST. JOHN'S DEVELOPMENT REGULATIONS AMENDMENT NUMBER 348, 2005

Take notice that the St. John's Development Regulations Amendment Number 348, 2005, adopted on the 18th day of April, 2005, has been registered by the Minister of Municipal and Provincial Affairs.

In general terms, the purpose of St. John's Development Regulations Amendment Number 348, 2005, is to add a new subsection to Section 5.1.3 ("Discretionary Powers of Council") to authorize Council to defer decisions on development applications and/or applications for amendments to the Development Regulations within a specified area of the City where Council has directed that a planning study pertaining to the future use and development of the specified area undertaken.

The St. John's Development Regulations Amendment Number 348, 2005 comes into effect on the day that this notice is published in *The Newfoundland and Labrador Gazette*. Anyone who wishes to inspect a copy of the amendment may do so at the Department of Planning, 3rd Floor, City Hall during regular business hours (Monday through Friday, 9:00 a.m. to 4:30 p.m.)

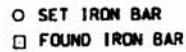

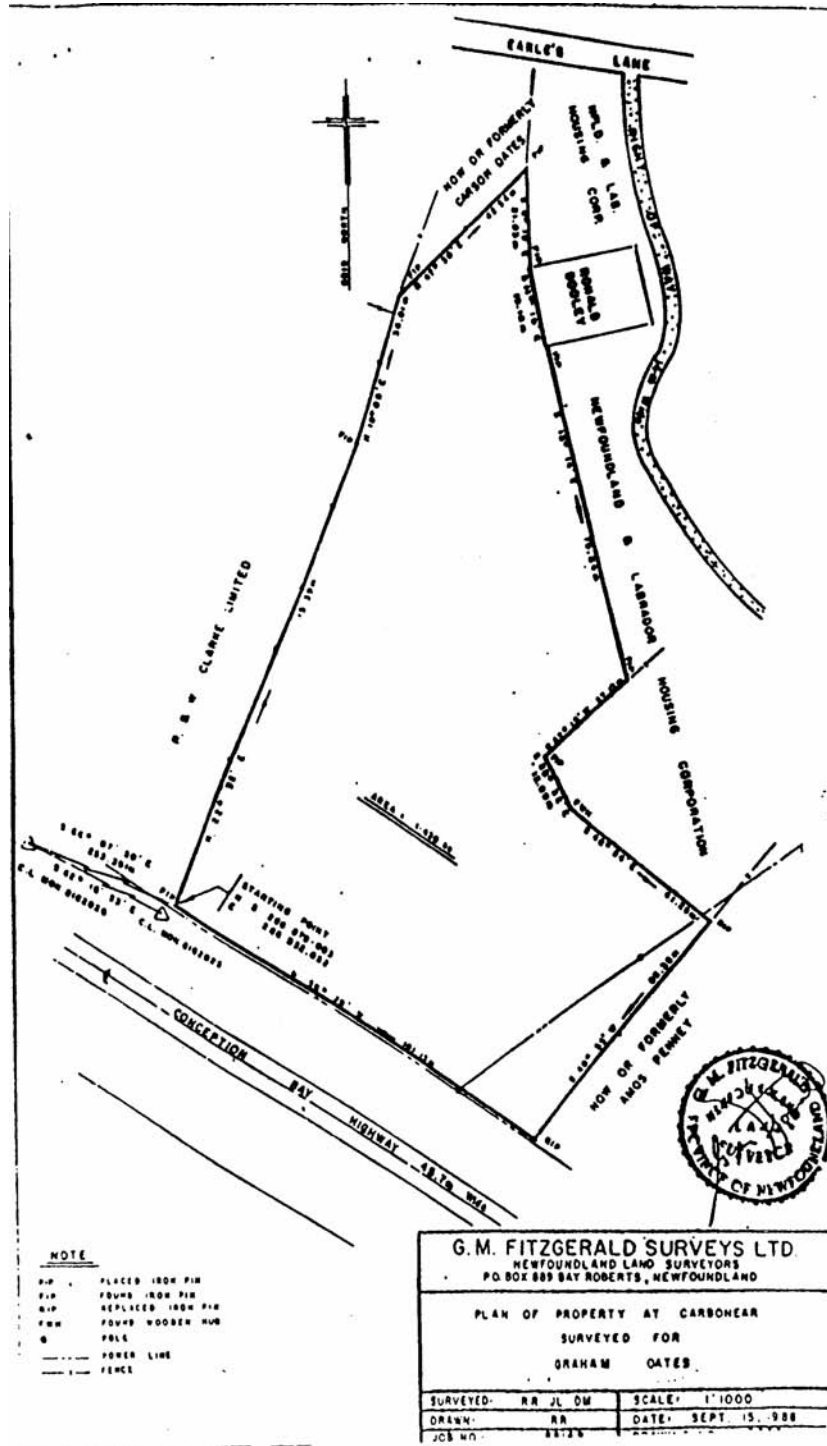
