Number 30, 2005 and the St. John's Development
Regulations Amendment Number 358, 2005, adopted on
the 3rd day of October, 2005, have been registered by the
Minister of Municipal and Provincial Affairs.

In general terms, the purpose of St. John's Municipal Plan
Amendment No. 30, 2005 is to redesignate the land on the
north side of Stavanger Drive from the Commercial
General Land Use District and the Open Space Land Use
District to the Residential High Density Land Use District,
the Residential Medium Density Land Use District and the
Open Space Land Use District in order to permit a
residential development.

In general terms, the purpose of St. John's Development
Regulations Amendment No. 358, 2005 is two fold:

- (a) To rezone the land on the north side of Stavanger
Drive from the Commercial Regional (CR) Zone
and the Open Space (O) Zone to the Apartment
High Density (A3) Zone, the Residential Medium
Density (R2) Zone and the Open Space (O) Zone
in order to permit a residential development; and
- (b) To add a reference in Section 10.14.3 (f) of the
Development Regulations ("Maximum Building
Height – Apartment High Density (A3) Zone")
that the maximum building height for the site on
the north side of Stavanger Drive has been
rezoned to the Apartment High Density (A3)
Zone is restricted to six (6) storeys.

Amendment Number 358, 2005 come into effect on the day
