In general terms, the Paradise Development Regulations Amendment No. 15 – 2006 deals with the following matters

- The discretionary placement of accessory structures in front of building lines on flanking streets.
- Changing “taxi stand” from a Discretionary Use to a Permitted Use within the Commercial/Light Industrial zone.
- Restrictions on the construction of accessory buildings (a) within 15 metres of the high water mark of ponds or streams and (b) within

Conservation zones included in Development Schemes adopted by Council.

- The correction of typographical errors.
