

1. Schedule A of the *Endangered Species List Regulations* is amended by

- (a) deleting the species "American Marten (Island of Newfoundland Population) - *Martes americana*"; and**
- (b) adding immediately before the species "Wolverine - *Gulo gulo*", the species "Red Knot - *Calidris canutus rufa*".**

2. Schedule B of the regulations is amended by

- (a) adding immediately before the species " Fernald's Braya - *Braya fernaldii*" the species "American Marten (Newfoundland Population) - *Martes americana atrata*", the species "Chimney Swift - *Chaetura pelagica*" and the species "Common Nighthawk - *Chardeiles minor*"; and**
- (b) deleting the species "Peregrine Falcon (anatum)" - *Falco peregrinus anatum*" and "Peregrine Falcon (tundra)- *Falco peregrinus tundrius*".**

3. Schedule C of the regulations is amended by adding immediately before the species "Polar Bear - *Ursus maritimus*" the species "Peregrine Falcon (anatum)- *Falco peregrinus anatum*" and the species "Peregrine Falcon (tundra) - *Falco peregrinus tundrius*".

1. Section 20 of the *Members' Resources and Allowances Rules* is amended by adding immediately after subsection (5) the following:
