Take notice that the Town of Humber Arm South Municipal Plan Amendment No.1, 2007 and Development Regulations Amendment No. 1, 2007 as adopted on the 13<sup>th</sup> day of November, 2007 and approved on the 8<sup>th</sup> day of January, 2008, have been registered by the Minister of Municipal Affairs.

The purpose of these amendments is to: accommodate existing residential development along Hillview; remove the Comprehensive Development Area policies and designation to replace it with the Residential Infill and Rural Resource designations; and, to redesignate a portion of land designated Recreation next to the recreational area adjacent the Town Office to Residential Infill – land which is being used for a dwelling and not in use for recreational purposes.

The area being redesignated to Residential Infill along Hillview Road is fully serviced and contains roughly twelve dwellings. Some additional developable land has

been included in this redesignation to Residential Infill west of Webcon Road and accessed by Eddy Russell's Road and Webcon Road to accommodate future residential development. Land Use Zoning Map 1 is to be brought into compliance with Future Land Use Map Sheet 1 by rezoning a site between Webcon Road and Clarke's Brook to Mineral Working.

The Municipal Plan Amendment No. 1, 2007 and Development Regulations Amendment No. 1, 2007 come into effect on the day that this notice is published in *The Newfoundland and Labrador Gazette*.


