TO: FEE-FOR-SERVICE and BLENDED CAPITATION FAMILY PHYSICIANS

RE: Eligible Family Physicians Invited to Apply for the Rural Community Comprehensive Care Bonus

Applications are now being accepted for the Rural Community Comprehensive Care Bonus (RCCCB) for the period from September 30, 2024, to September 30, 2025. Please be aware that an additional day has been added to the 2024-2025 RCCCB bonus period. This action will allow the RCCCB bonus periods, in future years, to fall in sync with the Memorandum of Agreement's (MOA) anniversary date of October 1st.

An application form has been included with this newsletter for ease of reference. The Rural Community Comprehensive Care Bonus is guided by Schedule Q of the MOA between Government and the Newfoundland and Labrador Medical Association. Please refer to [MCP Newsletter 22-23](#) for additional information.

As noted on the application physicians must submit their applications by December 31, 2025. All applications will be adjudicated after December 31st, 2025, and payments processed before March 31st, 2026. It will appear on the remittance statement as "1459 RCCC Bonus Program".

The RCCCB provides \$10,000 per year to eligible family physicians. That amount will be prorated, where necessary, in situations where the physician is on parental leave, retires, or enters practice partway through the bonus period. Other situations may be considered and are subject to the approval by the Department of Health and Community Services and the NLMA.
