**RE: RATES UPDATED AS PART OF IMPLEMENTATION OF 2023-2027
MEMORANDUM OF AGREEMENT**

The Government of Newfoundland and Labrador and the Newfoundland and Labrador Medical Association (NLMA) have signed a new Memorandum of Agreement (MOA) effective from October 1, 2023, to September 30, 2027. In accordance with the MOA, the rates below will be retroactive to the applicable effective date for annual increases.

Please note that all rate changes are subject to the billing rules in the MCP Payment Schedule preamble.
