**TO: CATEGORY 'B' EMERGENCY PHYSICIANS**

**RE: UPDATED LIST OF CATEGORY 'B' SITES BY TIER CATEGORY UNDER THE INTERIM RATE STRUCTURE**

As previously communicated in MCP Newsletter 22-09 ([BILLING-CODES-FOR-INTERM-RATE-STRUCTURE-3.pdf \(gov.nl.ca\)](#)) and updated with MCP Newsletter 22-22 ([CHANGES-TO-CATEGORY-'B'-INTERIM-RATE-STRUCTURE.pdf \(gov.nl.ca\)](#)) the Category 'B' Emergency Department Interim Rate Structure was introduced. This interim rate structure has been extended to March 31, 2025.

Category 'B' facilities in Harbour Breton, Springdale, Old Perlican, Bonne Bay, and Placentia Health Centre have been updated to Tier 3 status to recognize Emergency Department volumes above 7,000 annually at those sites. Effective dates for each facility have been communicated to NLHS.

For ease of reference, an illustrative table, which shows the applicable remuneration and fee codes for each payment modality and tier, is attached. A list of sites for all three remuneration tiers is also attached.

Please note, there are no changes to the existing billing codes associated with the introduction of the third tier and physicians should continue to bill either 611030, 611040, or 611050 as appropriate (using the applicable rates) to receive their incentive bonus.

**Note:**

- Regardless of tier, physicians will collect their base pay (either from their RHA or by billing MCP) **AND** will bill MCP using codes A, B or C (as determined by their shift).
- The total daily rate is based on a full 24-hour shift (8:00 a.m. – 7:59 a.m.). If only a portion of the day is worked, the bonus is broken down into an hourly rate based on the total number of hours in that shift (Weekdays: 10 hour day shift, 14 hour night shift; Weekends: 24 hour full day shift).
- Billing codes outlined in the rate table remain the same regardless of their Category B location or tier – only the rate associated with that code will change.
- Physicians **MUST** bill MCP using the codes in the rate table to receive their incentive bonus – physicians have 90 days from the date of service to submit their claim to MCP for processing (either via mail, paper claims, or through electronic billing).
