- c) set the date of Public Hearing for March 14, 2024 for the public hearing with the Section 20 requirement for written submission of objections/submissions for the Commissioner responsible for the public hearing to consider objections and submissions.



# **TOWN OF BISHOP'S FALLS DEVELOPMENT REGULATIONS AMENDMENT No. 13, 2023**

## **BACKGROUND**

The Town Council of Bishop's Falls wishes to amend its Development Regulations. The proposed amendment seeks to change the 2015-2025 Development Regulations Land Use Zoning Map.

In general terms, an area of land on Knights of Columbus Road will be rezoned from "Conservation" to "Residential Medium Density" on the Land Use Zoning Map of the Development Regulations, 2015-2025. This is in a response to a request for residential development in this area.

## **PUBLIC CONSULTATION**

During the preparation of this proposed amendment, Council undertook the following initiatives so that individuals could provide input A Notice was published in the NL Wire on January 3, 2024; published on the Town website on December 15, 2023; published on the Town Facebook page on December 15 and 29, 2023 and January 12, 2024.

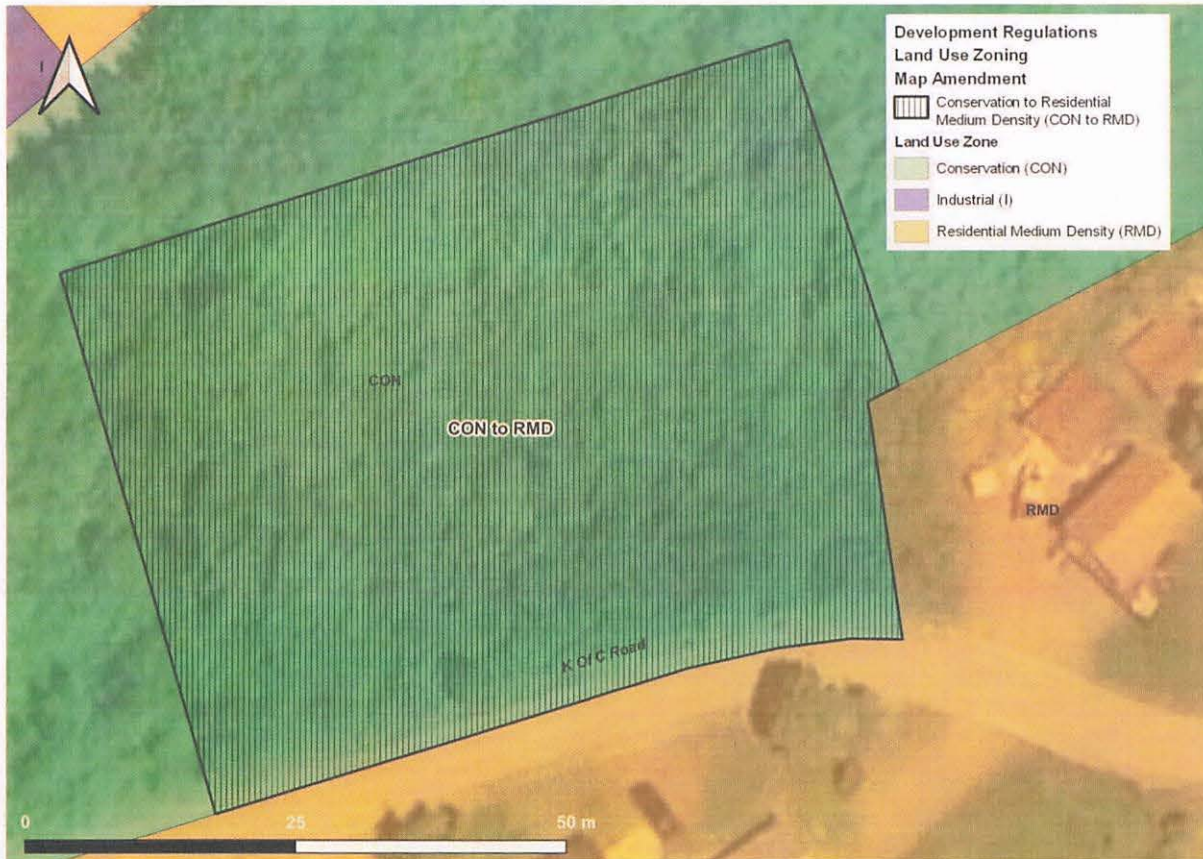
No submissions or objections were received by the Town by the deadline of January 19, 2024.


