**BACKGROUND**

The Town Council of Bishop's Falls wishes to amend its Municipal Plan. The proposed amendment seeks to change the 2015-2025 Municipal Plan Future Land Use Map.

In general terms, the area of 64 Main Street will be redesignated from "Industrial" to "Commercial" on the Future Land Use Map of the Municipal Plan, 2015-2025.

This is in a response to a request for a child care facility at this location. Note that the site immediately west of the parcel of land was re-designated to "Commercial" in 2023 as well.

**PUBLIC CONSULTATION**

During the preparation of this proposed amendment, Council undertook the following initiatives so that individuals could provide input. A Notice was published in the NL Wire on January 3, 2024; published on the Town website on December 15, 2023; published on the Town Facebook page on December 15 and 29, 2023 and January 12, 2024.

No submissions or objections were received by the Town by the deadline of January 19, 2024.


