IN GENERAL TERMS, the purpose of the ST. JOHN'S URBAN REGION REGIONAL PLAN AMENDMENT NO. 2, 2020 is to facilitate the TORBAY MUNICIPAL PLAN AMENDMENT NO. 4, 2020 AND DEVELOPMENT REGULATIONS AMENDMENT NO. 8, 2020 to accommodate a proposal for a seven (7) lot residential subdivision

MUNICIPAL PLAN AMENDMENT NO. 4, 2020, will re-designate a parcel of land in conjunction with a seven (7) lot residential subdivision located at the end of Bernice Drive from Rural to Residential.

DEVELOPMENT REGULATIONS AMENDMENT NO. 8, 2020 will rezone the same parcel of land from Rural (RUR) to Residential Large Lot (RLI).
