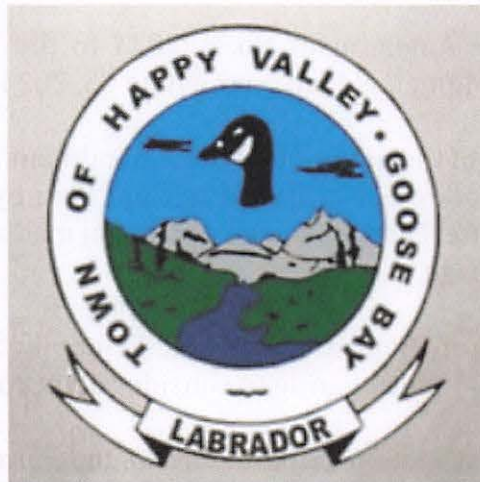

- c) set the day of August 8, 2024, at 12-noon at the Town Hall for the holding of a public hearing to consider objections and submissions.







**BACKGROUND**

The Town Council of Happy Valley-Goose Bay wishes to amend its Municipal Plan. The proposed amendment seeks to change the 2018-2028 Municipal Plan.

Council will also consider an associated amendment to the 2018-2028 Development Regulations.

The Town of Happy Valley-Goose Bay has received a request by an applicant to amend the designation of the land behind their residence on 25 Montagnais Street from Conservation to Residential to allow for residential use of the land. This extension of the boundary will match the Residential designation of adjacent properties and does not negatively affect the overall open space area.

**PUBLIC CONSULTATION**

During the preparation of this proposed amendment, Council undertook the following initiatives so that individuals could provide input: the Notice was circulated on the Community Contact Platform on April 25, 2025 and it was posted on the Town website and Town Facebook page on April 24, 2024. There were two comments received which were in the nature of enquiries for further information regarding the amendment. No objections were expressed with regard to the amendment.
