TOWN OF ST. LAWRENCE DEVELOPMENT REGULATIONS AMENDMENT NO. 3, 2025

BACKGROUND

This amendment to the Development Regulations is intended to comply with Municipal Plan Amendment No. 3, 2025.

The Town of St. Lawrence has received an application to create a building lot for construction of a residential dwelling located on Tower/Burke's Road in Little St. Lawrence. The property is 1.430 sq meters with 31m of frontage on the road. The property is serviced with water supplied and managed by the Little St. Lawrence Local Service District.

MUNICIPAL PLAN POLICY

In the Municipal Plan, the subject property is designated Rural. This land use designation does not permit residential dwellings. In considering the proposed development and recognizing a need for new building lots in the area, the Council prepared Municipal Plan Amendment No. 3, 2025 to extend the Mixed Development Land Use designation along the street to include the proposed lot.

DEVELOPMENT REGULATIONS

The property that is the subject of the application included in Municipal Plan Amendment No. 3, 2025, is zoned Rural on the Land Use Zoning Map. To comply with the Municipal Plan Amendment, the lands in question will be rezoned Mixed Development.

Development will be required to comply with the standards and conditions for permitted and discretionary uses included in the Mixed Development land use zone.

PUBLIC CONSULTATION

The public consultation process for this amendment was the same as that for the Municipal Plan Amendment No. 3, 2025.

AMENDMENT

The St. Lawrence Development Regulations shall be amended as follows:

1. By rezoning lands along Tower/Burke's Road, Little St. Lawrence, from the Rural land use zone to the Mixed Development land use zone as shown on the attached Land Use Zoning Map 2.
