IN GENERAL TERMS, CONCEPTION BAY SOUTH MUNICIPAL PLAN AMENDMENT NO. 33, 2024 re-designates land at 2-10 Buckleys Path from the "Residential Low Density" to the "Residential Medium Density" designation and DEVELOPMENT REGULATIONS AMENDMENT NO. 33, 2024 re-zones the land from the "Residential Low Density (R-I)" to the "Residential Multi Unit (RMU)" zone.
