TOWN OF CARBONEAR DEVELOPMENT REGULATIONS AMENDMENT NO. 35, 2018

BACKGROUND

This amendment to the Development Regulations is intended to comply with Municipal Plan Amendment No. 24, 2018.

The Town proposes to rezone lands on the south side of Clarke's Road from the Rural land use zone to the Residential-Rural land use zone to allow residential development.

PUBLIC CONSULTATION

The public consultation process for this amendment was the same as that for the Municipal Plan Amendment No. 24, 2018.

AMENDMENT

The Carbonear Development Regulations shall be amended as follows:

1. Rezoning land on the south side of Clarke's Road from the Rural (Rur) land use zone to the Residential Rural (RR) land use zone.
2. The lands to be rezoned are shown on the attached Map 2 - Town of Carbonear Development Regulations, Land Use Zoning Map - 2 Amendment No. 35, 2018.
3. Adding as Condition 2 to the Residential-Rural land use zone, the following:
 2. **Groundwater Assessment**
An assessment of the quality and quantity of groundwater shall be required in accordance with the Provincial Policy on Groundwater Supply Assessment and Reporting Guidelines for Subdivisions Serviced by Individual Private Wells;

and renumbering the conditions that follow accordingly.


