

Under the authority of section 16, section 17 and section 18 of the *Urban and Rural Planning Act 2000*, the Town Council of La Scie


- a) adopted the La Scie Development Regulations Amendment No. 3, 2006 on the 5th day of March, 2007.

DEVELOPMENT REGULATIONS AMENDMENT NO. 3, 2006

Schedule C - Open Space Zone - Discretionary Use Classes, WHICH STATES:

DISCRETIONARY USE CLASSES - (see Regs. 22 and 86)

Outdoor assembly, conservation, disposal site, animal, antenna, cemetery, service station, mineral working.

IS AMENDED TO STATE:

DISCRETIONARY USE CLASSES - (see Regs. 22 and 86)

Animal, antenna, cemetery, conservation, mineral working, outdoor assembly, recreational open space, seasonal residential, service station and solid waste disposal.
