Re: Call for Applications - 2024-2025 Municipal Capital Works

Date: August 7, 2023

The Department of Transportation and Infrastructure is inviting eligible funding recipients to submit applications for its 2024-2025 Municipal Capital Works Program.

The deadline to submit applications is September 29, 2023.

This intake is for the Municipal Capital Works (MCW) provincial funding program only. This means that municipalities who receive Multi-Year Capital Works (MYCW) funding are asked to hold applications for future federal programs as they are ineligible for MCW.

While there is no restriction on the type of application that can be submitted during this call, applications that suitably address existing Boil Water Advisories, compliance with federal Wastewater Systems Effluent Regulations, or the impacts of climate change are of particular interest.

The Application Guide addresses the submittal requirements of the Municipal Capital Works application and program highlights. This Guide, along with other important information, can be found on our website at:

MI has revised the Project Construction Estimate form to specifically include escalation and contingency allowances. This form will be required for all infrastructure funding applications; those missing the form may be rejected.

All submission requirements outlined in the Application Guide should be provided by the deadline as late or incomplete applications may not be considered.
