**Re: Implementation of the First Thirteen National Operational Statements (NOS) –
Newfoundland and Labrador Region**

The Habitat Management Program of the Department of Fisheries and Oceans Canada is pleased to announce the official implementation of National Operational Statements for low risk activities. As noted in the attached informational brochure, these statements will present proponents with up-front guidance on how to carry out a specific activity as well as how to design low risk projects in a fish habitat friendly way. Their intention is to provide a "bottom-line sign-off", which definitively tells the proponent that if they follow the recommended measures while carrying out their work, they are in compliance with the Fisheries Act, and a review by DFO is not required.


As of April 1, 2005, the following thirteen (13) NOS are in effect within the Newfoundland and Labrador Region:

Other additional Operational Statements will be developed as new low risk activities are identified over the coming years.

The DFO is confident that the implementation of these Operational Statements will benefit both the Department as well as its clients. HMP staff will spend less time reviewing routine projects, and more time on those projects posing a higher risk to fish habitat, as well as on monitoring. Proponents of low risk activities will now be able to proceed with their undertaking without a DFO review.
