This is to provide clarification on the accepted use of tendering and advertising services provided by the Engineering Support and Services Division (the 'Tendering Division').

Please be advised that projects approved under the Gas Tax Program are not currently eligible to receive these services from the Tendering Division and therefore owners will have to make other arrangements for tendering and advertising.

Owners with funding approved under the Municipal Capital Works Program, Multi-Year Capital Works Program, Special Assistance Grants, Nunatsiavut Government Funded Projects, and other funding programs as approved are required to continue to work with the Tendering Division for provision of tendering and advertising services.

In circumstances where owners are using Gas Tax funding to contribute to their share of a Municipal Capital Works project then the Tendering Division shall still be used.
